Sarawak Timber Association (STA) wishes to submit its feedback on the Enquiry Draft Version of the Malaysian Criteria and Indicators for Forest Management Certification or MC&I Forest Management Certification. Our feedback are as following:

**1. General Comments**

**a. Manual, Procedures and Guidelines for Sustainable Forest Management Certification (MPGSFMC)**

The MPGSFMC or so-called "The Green Book" consists of twelve (12) different manual, procedures and guidelines. It has been quoted as a verifier without reference to any particular manual, procedures or guidelines in indicators 3.3.1, 5.1.2, 5.3.1, 5.5.1, 5.5.2, 6.2.1, 6.2.2, 6.3.2, 6.5.1, 6.5.2, 6.5.3, 6.5.4, 8.1.1 and 9.1.1. Therefore, to avoid confusion / misinterpretation, the specific manual or procedures or guidelines (as contained in the MPGSFMC) that should be quoted on a verifier for the indicator must be clearly stated.

**b. Internal Audit**

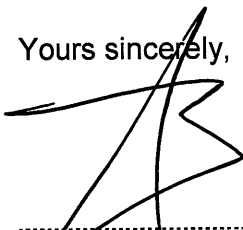
Internal audit, management review and action plan should be internal processes carried out by the FMU owner based on her capabilities and resources available and at the discretion of the FMU management. Therefore, requirement of its implementation as indicated in Appendix A should be simplified and reduced in scope and that the negative results arising from the internal audit and management review should not be used as a yardstick for the issue of non conformity report during certification audits.
