CORPORATE PROFILE

he Malaysian Timber Certification Council (MTCC) is an independent organisation established in October 1998 to develop and operate the Malaysian Timber Certification Scheme (MTCS). Incorporated under the Companies Act 1965 as a company limited by guarantee, MTCC is governed by a Board of Trustees and started its operation in January 1999.

MTCC's main activities are to:

- Operate a voluntary national timber certification scheme, the MTCS
- Cooperate and liaise with the appropriate standards setting body in formulating standards related to timber certification and keeping them under review periodically
- Process applications for timber certification, exercise control over assessments of forest management and chain-of-custody in the applicant enterprises, and make decisions regarding the applications for certification
- · Formulate procedures and guidelines for assessment of forest management and chain-of-custody
- Implement a system to monitor the operation of the MTCS, including appeals procedures, surveillance mechanism for periodic review of compliance by certified enterprises, and rules for the use and issuance of certificates
- Liaise closely with the national accreditation body and other certification organisations in matters related to timber certification
- Coordinate with national, regional and international bodies related to timber certification to facilitate cooperation and mutual recognition arrangements
- · Conduct programmes to promote and publicise the MTCS, both locally and internationally



BOARD OFTRUSTEES



CHAIRMAN'S STATEMENT

t is with pleasure and much satisfaction that I present this Annual Report detailing the work, activities and progress of MTCC for 2007. The year had been unusually busy, straining and stretching the small but dedicated secretariat resources led by Mr. Chew Lye Teng. Equally, the year had chalked much progress. Indeed, the MTCC has reached a major milestone in its growth and development and is poised to gain a higher level of international market acceptance and meet public procurement policies of major consuming countries for sustainable timber.

As indicated in this report, there has been a small increase in the total area of certified forests worldwide but with little increase for natural tropical forests. In this context Malaysia is the biggest contributor with almost four million hectares under the MTCS and another 55,000 hectares under the FSC scheme.

Implementing sustainable management and certification of natural tropical forests is a huge challenge demanding skills, strong institutions and resources, both financial and human, which are scarce in developing countries. It is therefore most courageous and creative of the European Union (EU) in promoting a Voluntary Partnership Agreement (VPA) under its Forest Law Enforcement Governance and Trade (FLEGT) Action Plan, under which it cooperates with partner countries to develop a Legality Assurance System (LAS) for timber products. The LAS, which is subject to third party monitoring, will assure that only legal timber will be able to enter markets in the 27 member states of the EU. Legal timber, verified through the LAS, is therefore a major milestone on the long and difficult journey to achieve sustainable timber. The VPA is thus a pragmatic initiative that will play a strategic and catalytic role in progressing towards sustainable forest management (SFM) and certification. Malaysia is currently negotiating with the EU to conclude

a VPA and MTCC's experience in stakeholder consultations, standard setting and auditing is invaluable in the formulation of the Malaysian Timber Legality Assurance System (TLAS).

The year under review was also a period of transition for the use of the *Malaysian Criteria and Indicators for Forest Management Certification* [*MC&I*(2002)], the new and more stringent standard. I note with much satisfaction that the Negeri Sembilan and Pahang Forest Management Units (FMUs) were the first to meet the requirement of the *MC&I*(2002), thanks to the dedication of the forest managers in these two states. Other FMUs awarded certificates under *MC&I*(2001) are making steady progress to meet the requirements of the new standard.

Another noteworthy development is the finalization of the draft of the MC&I for certification of forest plantations which had been initiated in 2006 by a special Technical Working Group (TWG). The field test of this draft MC&I (Forest Plantations) will be conducted by independent assessors to be appointed by the National Steering Committee (NSC) next year.

Also noteworthy is work towards the implementation of a new institutional arrangement for the MTCS. In this, MTCC collaborated closely with Department of Standards Malaysia (Standards Malaysia), the national Accreditation Body (AB). Under this new arrangement, MTCC will play the role of the National Governing Body (NGB). Assessment and award of certification will be made by Certification Bodies (CBs) which need to be accredited to the AB. Such an arrangement, in the separation of functions, will be in compliance with international principles and norms.

The MTCC management has also been busy making preparations to submit the MTCS for endorsement by the Programme for the Endorsement of Forest Certification Schemes (PEFC) to which MTCC had been a member since 2002.

In view of the foregoing developments, MTCC can look forward to the coming year with greater confidence. In this context, I wish to pay special tribute to the members of the Board Of Trustees, NSC, TWGs, the Ministry of Plantation Industries and Commodities, the Ministry of Natural Resources and Environment, the Forestry Departments in Sabah, Sarawak and Peninsular Malaysia and all stakeholder groups for their sustained support which has enabled the MTCS to become one of the foremost national certification schemes for both natural and plantation forests in the tropics.

he momentum of the work carried out in 2006 in the change to the use of the new forest management certification standard [MC&l(2002)] in the MTCS was maintained in 2007, which saw the assessment of six of the nine certified FMUs and assessment of one new FMU to the requirements of the MC&l(2002). These assessments resulted in two FMUs (Negeri Sembilan and Pahang) becoming the first and second FMUs respectively, to be awarded the new Certificate for Forest Management for compliance with the MC&l(2002). In addition, pre-assessments of two new FMUs to the requirements of the MC&l(2002) were carried out.

The success achieved by the Negeri Sembilan and Pahang FMUs in complying with the stringent requirements of the MC&l(2002) is a clear vindication of MTCC's adoption of a phased approach in implementing timber certification in Malaysia. The phased approach has enabled our forest managers to strengthen and improve their procedures, documentation and field practices, as well as their human resources, based on their experience with the MC&l(2001) standard used in the first phase, thus enabling the FMUs concerned to make a reasonably smooth transition when assessed for compliance with the requirements of the MC&l(2002).

Further progress was achieved in the preparations for the implementation of the new institutional arrangement for the MTCS. Beginning in April, only CBs which had been accredited with the Standards Malaysia, the national accreditation body, under relevant ISO guides such as Guide 62, 65 or 66 under other programmes were appointed to conduct assessments and surveillance visits under the MTCS. Resulting from the work of the TWG, in which MTCC played an active role, Standards Malaysia announced in October that it had finalised its accreditation programme for forest management system certification, and its readiness to accept applications from potential CBs for accreditation under this new programme.

The number of holders of the MTCC *Certificate for Chain-of-Custody* increased from 99 to 113. A total of 70,385 cubic metres of MTCS-certified timber products were exported. This brought the cumulative total exported since July

2002 to 201,206 cubic metres. South Africa, South Korea, the United States of America, Japan and Mauritius were added to the list of countries importing MTCS-certified products, bringing the total number to 17.

With regard to the MTCC-Hamburg project, the main milestones in the activities carried out were the Inception Workshop in January and the Mid-Term Workshop in June. Both these Workshops were well-attended by representatives from the various stakeholder groups. MTCC was also very pleased that the representatives of Free and Hanseatic City of Hamburg (FHH), German Timber Trade Federation (GTTF), German Agency for Technical Cooperation (GTZ) and University of Hamburg (UHH), its partners in this project, were able to attend the Mid-Term Workshop as well as the post-Workshop field visit.

There was further progress in the work on the development of the standard for the certification of forest plantations. Following deliberations of the TWG, the draft forest plantation standard, the *MC&I*(Forest Plantations), was subject to public comment from 30 April to 30 June through various channels. The draft *MC&I*(Forest Plantations) was subsequently reviewed by the TWG to take into account the comments received, and preparations for the field-testing of the draft standard were made.

Efforts to promote the scheme were continued, including participation in the Working Visit by YB Datuk Peter Chin Fah Kui, Minister of Plantation Industries and Commodities, to Australia (Sydney and Hobart), the International Green Week Fair in Berlin, the German Timber Day in Cologne, and the Malaysia International Commodity Conference and Showcase (MICCOS) 2007 organised under Ministry of Plantation Industries and Commodities.

MTCC continues to encourage cooperation and dialogue among the various stakeholder groups pertaining to issues related to SFM. In this connection, MTCC helped to organise the second Malaysian Forest Dialogue (MFD) as a member of the Steering Committee for the MFD. The second MFD focused on native customary rights (NCR) in forested land, SFM and forest communities and financing of SFM.

In carrying out all these activities, I am most grateful for the cooperation and support that we continue to receive from the forest managers, timber companies, independent assessors, facilitators and representatives of the environmental, social and economic stakeholder groups in Sabah, Sarawak and Peninsular Malaysia.

I wish to thank the Chairman and Board of Trustees, as well as the Members of MTCC, for their continued guidance and support to the MTCC management in operating the MTCS. Last but not least, I would like to thank my team - the MTCC managers, executives and supporting staff, for the diligence and commitment that they have shown throughout 2007 which has enabled the MTCS to achieve further progress and improvements.

FOREST MANAGEMENT CERTIFICATION

A total of nine FMUs were subjected to pre-assessment / assessment / verification against the requirements of the MC&I(2002) as follows:

As a result of the assessment/verification, the Negeri Sembilan and Pahang FMUs became the first and second FMUs respectively to be certified under the requirements of the MC&I(2002). The other FMUs assessed were not certified due to the issuance of at least one major corrective action request (CAR).

Surveillance visits against the requirements of the MC&l(2001) were conducted on two FMUs i.e. the Terengganu and Sela'an-Linau FMUs. As a result of the surveillance visit, the suspension of the Certificate for Forest Management for the Terengganu FMU imposed on 13 December 2006 was lifted on 18 October, and the certificate remained valid until it expired on 13 December.

Implementing reduced impact logging in Pahang FMU

The surveillance visit conducted on the Sela'an-Linau FMU resulted in the raising of the minor CAR, relating to a blockade (SEL-07), to a major CAR. Following the verification conducted on 2-4 May on the actions to be taken to address the major CAR, the assessor concluded that the major CAR cannot be closed and recommended the suspension of the *Certificate for Forest Management*.

However, following an appeal by the FMU, an extension of six months was granted, based on the exceptional circumstances faced, to allow the FMU more time to implement a specific plan of actions to address the major CAR. The verification of actions taken was conducted on 28-30 November. As a result of progress made to resolve the dispute, the assessor agreed to close the major CAR and recommended that the certificate be maintained.

In addition, the *Certificate for Forest Management* issued to the Selangor FMU against the *MC&I*(2001) expired on 13 December.



INDEPENDENT ASSESSORS / RECOGNISED CERTIFICATION BODIES

In line with the implementation of the new institutional arrangement for the MTCS, with effect from 1 April 2007, only CBs accredited with Standards Malaysia under the relevant MS ISO Guides 62, 65 or 66 under other programmes [such as the MS ISO 9001 (quality management system) and MS ISO 14000 (environmental management system)] were recognized and appointed to conduct assessments and surveillance visits for forest management and chain-of-custody (CoC) certification. This was a measure taken to encourage MTCC registered assessors to become accredited to Standards Malaysia, as preparation for the implementation of the new institutional arrangement. The recognised CBs are as follows:

- i. SGS (Malaysia) Sdn. Bhd.
- ii. SIRIM QAS International Sdn. Bhd.
- iii. Moody International Certification (M) Sdn. Bhd.

In line with the measures taken within Malaysia, MTCC also decided that overseas-based CBs that are accredited against a CoC certification programme endorsed by the PEFC Council would be allowed to conduct assessments and surveillance visits against the *Requirements for Chain-of-Custody Certification (RCOC)* under the MTCS. Under this arrangement, the following two overseas-based CBs were accepted into the list of recognised CBs:

- i. Control Union Certifications B.V. (CUC), The Netherlands
- ii. Certification and Timber Grading Limited (CATG), United Kingdom

The total number of Peer Reviewers registered under the MTCS to provide expert and independent review of assessment reports of FMUs prepared by assessors remained at 16.

EXPORT OF MTCS-CERTIFIED TIMBER PRODUCTS

In 2007, a total of 70,385 m³ of MTCS-certified timber products was exported to a number of destinations which included five new destinations, i.e. South Africa, South Korea, United States of America, Japan and Mauritius. With these new destinations MTCS-certified timber products have now been exported to 17 countries i.e. The Netherlands, Belgium, Germany, the United Kingdom, France, Australia, Greece, Denmark, Poland, Italy, Norway, Indonesia, South Africa, South Korea, United States of America, Japan and Mauritius. The United Kingdom was the biggest market for MTCS-certified products in 2007, accounting for 30,561 m³ (or 43.4%) of the total quantity exported. Records show that the largest volume of MTCS-certified products was exported in the month of May, reaching a total volume of 10,264 m³.

Hence, by the end of 2007, a total cumulative of 201,206 m³ of MTCS-certified timber products had been exported, with The Netherlands remaining as the biggest market overall, accounting for 97,499 m³ (or 48.4%) of the total quantity exported since July 2002. The certified products cover a wide range including sawn timber, moulding, laminated finger-jointed timber, plywood, furniture and furniture components, picture frames, flooring, and door and window components.




Figure: 1: Export of MTCS-Certified Timber Products

IMPLEMENTATION OF NEW INSTITUTIONAL ARRANGEMENT

ork towards the implementation of a new institutional arrangement (**Figure 2**) for the MTCS that was initiated in 2005 was further continued in 2007. MTCC has set a target date of 1 April 2008 for the establishment and operation of the new institutional arrangement, under which MTCC will continue to play the role of the national governing body (NGB) in the MTCS, while the independent assessors will become the CBs and are required to be accredited to Standards Malaysia, which is the national Accreditation Body (AB).

Besides being an important measure to further strengthen and enhance the acceptance of the MTCS in the international market, the new institutional arrangement is necessary as part of the preparations by MTCC for the submission of the MTCS to the PEFC Council for endorsement. Furthermore, the new arrangement will also meet the requirements of the public procurement policies for timber of key importing countries of Malaysian timber products, particularly in Europe such as the United Kingdom, Germany and The Netherlands.

One of the main activities towards the implementation of the new institutional arrangement was to cooperate with and assist Standards Malaysia in the development of accreditation programmes that will be implemented by Standards Malaysia for CBs operating forest management system certification and CoC certification. Towards this, the TWG that was formed in 2005 by Standards Malaysia held six meetings throughout 2007 to finalise the documentation and procedures for these accreditation programmes.

In October, Standards Malaysia announced that it had finalised its accreditation programme for forest management system certification and was ready to accept applications from potential CBs for accreditation under this programme.

Following the announcement by Standards Malaysia, MTCC also informed all its registered assessors regarding the finalisation of the accreditation programme, and reminded the potential CBs to obtain accreditation with Standards Malaysia so as to qualify as an accredited CB under the MTCS to carry out assessments for forest management certification.

A meeting was also held on 30 November between Standards Malaysia, MTCC and the potential CBs to discuss in detail the mechanism for the implementation of the finalised accreditation programme for forest management system certification.

In line with its decision to use only CBs accredited with Standards Malaysia beginning 1 April 2007, MTCC also decided that overseas-based CBs that are accredited against a CoC certification programme endorsed by the PEFC Council can now apply to be a recognised CB with MTCC to conduct assessments and surveillance visits against the *RCOC*. Under this arrangement, two overseas-based CBs were accepted as recognised CBs, namely Control Union Certifications B.V. (CUC) based in Zwolle, The Netherlands, and Certification and Timber Grading Limited (CATG) based in Lancashire, United Kingdom. This allows overseas timber companies applying for CoC certification under the MTCS to be assessed by these recognised CBs.

In addition, based on feedback obtained from the PEFC Council, MTCC developed an alternative to Appendix I of the PEFC Council international chain of custody standard (i.e. Technical Document Annex 4: *Chain of Custody of Forest Based Products - Requirements*) for the purposes of the MTCC label and declarations. Timber companies which comply with this document and PEFC Annex 4 will qualify to use both the PEFC and MTCC logos and/or declarations on their certified timber products, once the MTCS has been endorsed by the PEFC Council.

DEVELOPMENT OF MALAYSIAN CRITERIA AND INDICATORS FOR FOREST MANAGEMENT CERTIFICATION (FOREST PLANTATIONS)

he Third Meeting of the Technical Working Group (TWG) on MC&/(Forest Plantations) held on 6 February considered the various amendments made by the three regional consultations in finalising the draft MC&/(Forest Plantations) which was subsequently tabled for the consideration of the Tenth Meeting of the National Steering Committee (NSC) held on 27 March. The NSC considered the outcome of the regional consultations and the recommendations made by the TWG and agreed that the revised draft MC&/(Forest Plantations) be subjected to public comments over a 60-day period in line with the Rules on Standard Setting Process for Development of Malaysian Criteria and Indicators for Forest Management Certification (Forest Plantations).

Tenth Meeting of National Steering Committee

The draft MC&/(Forest Plantations) was subsequently subjected to public comments by the Malaysian stakeholder groups from 30 April to 30 June. The notification for public consultation/comment on the draft MC&/(Forest Plantations) was made through various channels such as the MTCC website, MTCC News, e-mail as well as through the post where soft/hard copies of the draft standard were sent to 144 organizations representing the various social, economic and environmental stakeholder groups, and relevant government agencies, to solicit their comments and feedback on the draft standard.

The comments received from the public consultation were deliberated by the Fourth Meeting of the TWG held on 21 August. A summary of the comments received, the outcome of the deliberations by the TWG on these comments, as well as the revised MC&I(Forest Plantations) were made available on the MTCC website. The TWG also agreed that the draft standard be subject to field testing in the three regions of Malaysia, i.e. Sabah, Sarawak and Peninsular Malaysia.

The field test of the draft MC&I(Forest Plantations) will be conducted by independent assessors to be appointed by the NSC Secretariat. The TWG agreed that a representative each from the various stakeholder groups will be invited to participate as observers in the field tests in the respective regions.

WORKING VISITTO AUSTRALIA

Datuk Peter Chin Fah Kui, Minister of Plantation Industries and Commodities led a five-member delegation to Australia for a Working Visit on 20-24 August with the objective of having discussions with his Ministerial counterparts on matters of interest to both countries, such as illegal logging, timber trade, SFM and timber certification. In addition, the working visit was aimed at (i) promoting closer cooperation between MTCC and Australian Forestry Standard Limited

(AFSL), which is the National Governing Body (NGB) of the national timber certification scheme in Australia, (ii) holding discussions with the timber trade associations on the promotion of Malaysian timber products in the Australian market and (iii) obtaining more information about the forest plantation practices in the State of Tasmania and the operations of the Ta Ann Tasmania veneer mill in Huon, Tasmania. MTCC was represented in the delegation by the Chief Executive Officer, Mr. Chew.

The discussion with Senator the Hon. Eric Abetz, Minister for Fisheries, Forestry and Conservation, covered a wide range of subjects, including cooperation between the two countries in the timber trade, timber certification, forest plantations, and in tackling issues such as illegal logging and trade in illegal timber. Senator Abetz highlighted the Australian policy on illegal logging which was about to be released. The policy provides practical measures that will help to sustainably manage the world's forests and reduce timber imports from illegal sources.

In the meeting with Mr. Paul Lennon, the Premier of Tasmania, Mr. Lennon expressed his satisfaction with the investment made by Ta Ann, which has created wealth and provided employment to the local community in the forestry-based region around Huon.

Following an exchange of information about the latest developments in the Australian Forest Certification Scheme (AFCS) and the MTCS, the discussion with Mr. Mark Edward of the AFSL covered the 'green premium' for certified products, the activities of the Green Building Council in Australia and the need for the PEFC scheme to be more aggressively promoted.

The meeting with the timber associations i.e. the Timber and Building Materials Association (TABMA), Timber Development Association (TDA) and Australian Timber Importers Federation (ATIF) dealt with the current situation of the building and construction sector in New South Wales, and the Australian government policy on the trade in illegal timber. The timber associations expressed their interest to work closely with Malaysia, especially MTCC, to promote its certification scheme in Australia.

In conclusion, this Working Visit has helped to further enhance cooperation between Malaysia and Australia in the fields of timber trade, SFM and timber certification, including efforts to combat illegal logging and trade in illegal timber products.



RECOGNITION OF MTCS

As a result of MTCC's continuous efforts to promote and seek recognition of its scheme, authorities in the following countries have recognised the MTCS:

The Danish Ministry of the Environment has included the MTCS as one of the accepted certification schemes in its document entitled *Purchasing Tropical Timber - Environmental Guidelines*, describing the MTCC certificate as providing a good guarantee of legal forest management, on its way towards becoming sustainable.







The Ministry of Agriculture and Forestry, New Zealand has listed the MTCS in the *New Zealand Timber and Wood Products Procurement Policy*.

The report commissioned by the United Kingdom's Central Point of Expertise on Timber (CPET), an expert group appointed by the Department for Environment, Food and Rural Affairs (DEFRA), United Kingdom concluded that the MTCC certificate provides assurance of legally harvested timber. The first review by the CPET in 2006 continued to accept the MTCS. In addition, CPET recognised that all MTCS-certified timber products meet the requirements for legality where previously only products containing 100% certified raw materials were recognised.





The Royal Horticultural Society of UK has listed the MTCS as one of the seven recognised certification schemes in its *Conservation and Environment Guidelines*.

The French Ministry of Environment and Sustainable Development and the Ministry of Agriculture, Food and Rural Affairs have listed the MTCS as one of the acceptable certification schemes in the French Policy on Public Procurement of Timber and Wood Products entitled *French National Timber Procurement Policy*.







The MTCS has been listed as one of the accepted certification schemes in the *Guideline for Verification on Legality and Sustainability of Wood and Wood Products* issued by the Forestry Agency, Ministry of Agriculture, Forestry and Fisheries, Japan.

By December, seven FMUs and 26 Holders of the MTCC *Certificate for Chain-of-Custody* have been accepted under the *Keurhout Protocol for Legal Origin* in The Netherlands.

CERTIFIED FORESTS UNDER VARIOUS CERTIFICATION SCHEMES

he total area of certified forests worldwide continued to increase and surpassed the 300 million ha mark in 2007, reaching a total of 305 million ha by year end, an increase of nearly 4% over the 2006 figure. However, the increase in certified forests did not change the continuing global trend of having more areas in the boreal and temperate forests of Europe and North America being certified under the PEFC and FSC schemes.





Figure 3: Certified Forests Under Various Certification Schemes

The 305 million ha certified globally still represent less than 10% of the total global commercial forest area. Of this total, nearly 95% are certified under the two major certification schemes, i.e. 194.38 million ha¹ (63.7%) under the PEFC scheme making it the largest in terms of forest area certified, and a further 93.86 million ha² (30.7%) under the FSC scheme. Of the rest, 11.74 million ha² (3.8%) are certified under the American Tree Farm System (ATFS), 3.94 million ha (1.3%) under the MTCS, with another 1.06 million ha² (0.3%) under the Indonesian Ecolabelling Institute (LEI) **(Figure 3)**.

The PEFC-certified forests include 75.96 million ha certified under the Canadian Standards Association (CSA), 39.30 million ha under the Sustainable Forestry Initiative (SFI) of USA, 7.85 million ha under the Australian Forestry Standard (AFS), 1.82 million ha under the Chilean Standard for Sustainable Forest Management (CERTFOR), and another 0.89 million ha under the Brazilian Programme of Forest Certification (CERFLOR).

In terms of geographical distribution (**Figure 4**), not much had changed by the end of 2007 compared with the situation in 2006. Still more than half (57%) of the world's certified forests are located in North America, while the EU/EFTA region has grown slightly to account for one-third (33%). However, the certified forest area that lies outside the North American and EU/EFTA regions still continues to account for only 10% of the global total, of which only 2% is in the Asia-Pacific region.

COOPERATION

MTCC-PEFC COOPERATION

he 11th PEFC Council General Assembly was held on 5 October in Munich, Germany. It was attended by member countries, extraordinary members, invited guests and members of the Board of Directors of the PEFC Council. MTCC was represented by the Chief Executive Officer, Mr. Chew.

The General Assembly keynote speech was delivered by Professor Michael Mainelli, the founding director of Z/Yen Group Ltd., a risk/reward management consultancy company based in the United Kingdom. In his keynote address, Professor Mainelli stated that PEFC played a crucial role in helping society to gain confidence that the forests managed sustainably and emphasized that the implementation and evaluation of the strategic plan was about the PEFC community making decisions.

The PEFC Chairman Mr. Michael Clark in his report for 2007 highlighted that the hectarage of PEFC certified forests has achieved a growth of more than 50%. More timber companies in a number of countries i.e. Morocco, India and Ireland have been awarded the first-ever PEFC certificates for chain-of-custody. In addition, the number of PEFC members has increased from 31 to

33 with the admittance of the *Sociedad de Productores Forestales del Uruguay* and the Pan African Forestry Certification (PAFC Cameroon), the latter pending submission of several required documents. The Slovenian system has successfully gained PEFC endorsement, while the France and the Czech Republic were re-endorsed for the next five years bringing the number of PEFC endorsed systems to 23.

The public procurement policies in Germany, UK as well as regional and local authorities in Italy, have given recognition to PEFC certified products. A new promotions office in Beijing, China has been launched to complement the existing initiatives in Japan and the United Kingdom in order to further contribute to the PEFC's position in the Asian markets. The PEFC Council has also launched the online global certified products database and has gained an official Observer Status in the Ministerial Conference for the Protection of Forests in Europe (MCPFE). The PEFC Council has also published the Guideline for the Investigation and Resolution of Complaints and Appeals and the standard for the Avoidance of wood from Controversial Sources which further defined PEFC's safeguards in this important area. The PEFC members also approved several changes to the PEFC Council technical documentation during the General Assembly, among them a change to the PEFC Technical Document Annex 4: Chain of Custody of Forest Based Products - Requirements.

One of the most significant agenda items was the PEFC's new Strategic Plan for the coming five years. The adoption of the new Strategic Plan marked a significant switch in the strategic direction of the PEFC from production to market access orientation. The PEFC Strategic Plan would be focusing on three inter-related operating strategies, i.e. (i) growth, (ii) market access and communications, and (iii) governance and operations.

As a measure to effectively deliver the new strategy, PEFC has undergone a governance review to ensure that it has the structures and procedures in place to meet the future demands on the organization. PEFC has also made mandatory a new Panel of Experts which would review all assessment reports for PEFC endorsement.

In terms of growth, over the next ten years, PEFC has planned to maintain its current share of over 60% of the total global capacity of certified industrial roundwood. PEFC would be managing this growth based on three criteria (i) the availability of appropriate resource and country specific expertise within the PEFC organization, (ii) the readiness of applicant countries to meet PEFC standards and (iii) the need to support existing PEFC members and chain of custody stakeholders in protecting and expanding existing business and in developing new markets for certified wood.

On the basis of these criteria, the plan assumed that increase in the certified area over the next five years would come from the following four main regions i.e. Russia, Asia/Pacific, Latin America and Africa. The Asia-Pacific region would therefore be one of the regions where the PEFC could be expected to focus its attention and resources in the next five years, and MTCC, as one of the PEFC members from this region, could play an important role in contributing to this growth.

MTCC-HAMBURG JOINT PROJECT

An Inception Workshop to brief and inform all relevant Malaysian stakeholders regarding the background, objective, scope and progress of implementation of the MTCC-Hamburg Joint Project was conducted in Kuala Lumpur on 9 January. The Workshop was attended by 32 participants representing the various environmental, social, economic stakeholder groups and the relevant government agencies. Dr. Reinhold Glauner representing the Federal Research Institute of Forest and Forest Products (BFH) and Dr. Michael Trockenbrodt from GTZ (Malaysian-German Forestry Education Project based in Sabah) also attended the Workshop.

A total of four meetings of the Joint Project Team (JPT) were held throughout the year to provide technical inputs, expertise and advice for the implementation of the project. The Second Meeting held on 9 January deliberated on the timelines for the appointment of consultants to conduct the gap analyses, as well as the scheduling of a Mid-term Workshop to present the outcomes of these analyses.

The Third and Fourth Meetings of the JPT held on 10-11 May and 25 June respectively discussed and finalised the response of the JPT on the gap analyses conducted by the four consultants, as well as made preparations for the Mid-Term Workshop on 26-27 June.



The aim of the Mid-Term Workshop was to brief and inform all relevant Malaysian stakeholders, as well as the German project partners regarding the progress of implementation of the project. The Workshop was jointly organized by the project partners, i.e. MTCC, the Free and Hanseatic City of Hamburg (FHH), German Agency for Technical Cooperation (GTZ), German Timber Trade Federation (GTTF), BFH and University of Hamburg (UHH). The Workshop was attended by 77 participants representing the various stakeholder groups and representatives from the project partners from Germany. In order to enable the German participants to have a first hand experience on SFM practices in Malaysia, a two-day field trip to Negeri

Sembilan FMU was organized on 28-29 June.

The Fifth Meeting of the JPT held on 5 November discussed the outcome and feedback received from the Mid-term Workshop, including the recommendations Group discussions to address the

identified gaps, and the progress of work related to the verifier check on the MC&I(2002). The Meeting also discussed the planning and implementation of project activities, in particular the three regional workshops to disseminate the project outputs scheduled in February 2008.

Mr. Reinhard Stuth, the State Secretary of City of Hamburg visited MTCC on 12 November and was briefed on the progress of the project implementation. Mr. Stuth was a member of the delegation of the Prime Minister of Schleswig-Holstein (Hamburg's neighbouring state in north Germany), Mr. Peter Harry Carstensen, who visited Malaysia on 10-13 November.

MALAYSIAN FOREST DIALOGUE (MFD)

The second Malaysian Forest Dialogue (MFD) was held on 22-23 October in Kuala Lumpur with the theme of *Challenges in Implementing and Financing Sustainable Forest Management*. The dialogue was organised by the MFD steering committee whose membership has expanded. The MFD steering committee comprised of HSBC Bank Malaysia Berhad, MTC, Business Council for Sustainable Development Malaysia (BCSDM), WWF Malaysia, Malaysian Nature Society (MNS), Malaysian Timber Industry Board (MTIB), Sabah Timber Industries Association (STIA), Sarawak Timber Association (STA), Sarawak Timber Industry Development Corporation (STIDC) and MTCC. The objectives of the MFD are to enhance awareness and share information on aspects affecting the forestry business, to highlight the changing market opportunities and expectations, to discuss the practical realities of implementing and financing sustainable forest management (SFM), as well as to encourage and promote active and constructive engagement amongst the various stakeholders within the Malaysian forestry and financial sectors.

The two-day dialogue focused on issues related to native customary rights (NCR), SFM and forest communities, socioeconomic issues with regards to SFM practices in Malaysia and financing SFM. A total of sixteen presentations were made.

The legal aspects related to NCR were deliberated at length, with the focus on the interpretation of the laws concerned. References to the landmark decisions made at the courts of law were debated by practitioners and academics during the dialogue. The discussion on NCR has enabled the MFD participants to better appreciate the complexities of the issues surrounding the rights of the native communities from the legal perspective. The practical issues related to NCR were also discussed by the companies and authorities involved. The

MFD participants recognised that the legal issues relating to NCR will take time to be resolved but acknowledged that concerns related to the rights of native communities will continue to impact the timber industry. In this regard, a more holistic approach in the operation of the timber industry is required in order to lead to a constructive and sustained engagement among the stakeholders. The dialogue also suggested that better coordination between the State and Federal authorities is needed in improving the social development and assistance programme for the native communities.

Another topic that was discussed was on financing SFM. The dialogue emphasised that third party certification was by far the internationally accepted way of proving legality and sustainability of timber products. Therefore, the timber industry was encouraged to hasten their uptake of timber certification. The MFD participants also noted that the timber industry should expect to face greater scrutiny and provide a high level of transparency in their financial and non-financial performance.

The MFD recognised the need to engage and invite more financial institutions and policy makers to the dialogue, noting that some financial institutions are averse to investing in the timber industry due to the perceived risks. Through their participation in the dialogue, the financial institution would be better informed of the needs and risks of the timber industry. On the other hand, the participation of more policy makers would facilitate high-level and inclusive discussions which would lead towards more collaborative and action-oriented recommendations and solutions to the complex forestry issues facing the stakeholders today.
