



ANNUAL GENERAL MEETING

The Eighteenth Annual General Meeting was held on 22 June in Kuala Lumpur during which the Audited Accounts for the Financial Year ended 31 December 2016, Reports of the Trustees and Auditors, and the Annual Report for the Year 2016, were tabled and adopted by the Members.

On behalf of the Board of Trustees of the Malaysian Timber Certification Council (MTCC), I present the Annual Report and the Audited Accounts of the Council for the financial year ending 31 December 2017.

The Year 2017 began on a bright note when in January, the Malaysian Timber Certification Scheme (MTCS) was accorded unconditional acceptance under the Public Procurement Policy for Sustainable Timber in the Netherlands - one of the key markets for MTCS certified timber products. With this recognition, the demand for MTCS-PEFC certified products is expected to increase as Dutch importers strive to meet the goal of the Covenant on 'Stimulating Sustainable Forest Management' to procure at least 95% of their tropical timber requirements from sustainable sources by 2020. Initiated in March 2017, the Covenant is signed by the wood industry, construction, furniture and retail sectors, trade unions, social organisations, and the government with the aim of stimulating sustainable forest management and the further reinforcement of international corporate social responsibility in the entire wood chain.

In addition to the Dutch recognition, the Tokyo Organising Committee of the Olympic and Paralympic Games (TOCOPG) 2020 continued to accept the MTCS as having fulfilled its 'Sustainable Sourcing Code' for the construction of the Olympic facilities despite pressures by some NGOs. This development is most welcome as Japan is an important market destination for Malaysia's timber products.

MTCC firmly believes that market demand for certified products is one of the key movers of forest certification. Hence, MTCC works closely with the Programme for the Endorsement of Forest Certification (PEFC) and other PEFC members in promoting demand for MTCS/PEFC certified products in both key and emerging markets. MTCC's active participation in the PEFC Asia Promotions Initiative is a case in point and MTCC will continue to seek support and expertise from the PEFC alliance to address issues of concern in the promotion of the MTCS in the international market.

On the domestic front, it is heartening to note that there is a heightened awareness for the protection and sustainable management of our forest and forest resources as demonstrated by the growing engagement of NGOs, indigenous peoples, and the media on forest-related issues. In addition, National policies such as the National Policy on Environment, National Policy on Biological Diversity, National Policy on Climate Change

and the National Roadmap on Sustainable Development Goals (SDG) are some of the initiatives that support the sustainable management of our forest and address environmental issues. These developments complement the efforts of the MTCC in promoting forest certification initiatives in the country. MTCC is certain that such developments will promote and increase the uptake of certification in Malaysia, which has been hovering around 30% of the permanent reserved forest for the past five years. Towards this end, MTCC welcomes and applauds the commitment of the Sarawak state government for mandatory forest management certification of all its long-term timber concessions by 2022.

MTCC has continued its efforts to promote the further uptake of certified timber in the domestic market. Two companies, which are well-known iconic brands in their sectors, namely Royal Selangor and Signature Manufacture Sdn Bhd obtained their chain of custody certification under the MTCS. We hope that the extensive and positive coverage they received will improve the visibility of the MTCS in the domestic market and motivate other local companies to embrace ethical and sustainable sourcing of their materials.

In 2017, MTCC also implemented two new outreach activities in the form of a Photography Contest and a Media Familiarisation Programme to engage the public in advancing our sustainability agenda. In addition, continuing the efforts of 2016, the MTCC Academic Award was presented to two outstanding students from the Faculty of Forestry, Universiti Putra Malaysia, while the Freezailah Forest Sustainability Award to a student from the Faculty of Science and Natural Resources, Universiti Malaysia Sabah.

Pursuing the sustainability agenda continues to be a challenge as demonstrated by the fact that globally only about 12% of the world's forest has been certified, with tropical forest accounting for 6.1% of these certified forests. At the national level, only 4.12 million ha or about 32% of the permanent reserved forests had been certified. Nonetheless, MTCC will endeavour to meet these challenges to ensure the effective implementation of the MTCS to protect the socio-economic and environmental benefits derived from the forest.

Finally, I would like to express my gratitude to the Board of Trustees for their continued support and guidance and to the MTCC management team for their dedication and commitment in implementing MTCC's activities.



On forest management certification, the total area of certified forests under the MTCS increased from 4.03 million hectares in 2016 to 4.12 million hectares in 2017. The increase was attributed to the addition of three new forest plantation management units (FPMUs) that were certified in 2017 bringing the total number of FPMUs to seven, in addition to the existing nine certified natural forest management units (FMUs).

In the case of chain of custody certification (CoC), a total of 41 new certificates were issued in 2017. Nonetheless, due to the withdrawal and expiry of 29 certificates and the suspension of seven certificates, the recorded increase in the total number of CoC certificate holders was modest, from 352 in 2016 to 357 in 2017.

In terms of export, the export volume of timber products certified under the MTCS showed a 24.9% increase from 190,405 m3 in 2016 to 237,793 m3 in 2017. The Netherlands provided the biggest market share, accounting for 36.4% of the total export, followed by the United Kingdom at 15.9%. Algeria, French Polynesia, New Caledonia, Philippines, Saint Lucia and Spain became the latest destinations for MTCS-certified timber products, bringing the total number of countries importing Malaysia's certified timber to 65.

The unconditional acceptance of the MTCS by the Dutch government under its "Public Procurement Policy for Sustainable Timber", and acceptance by the Tokyo Organising Committee of the Olympic and Paralympic Games 2020 under its "Sustainable Sourcing Code for Timber" were significant achievements for MTCC in 2017. This is in addition to nine other countries with active operational public procurement policy which have already accepted the PEFC endorsed MTCS, namely the United Kingdom, Germany, France, Denmark, Belgium, Finland, Switzerland, Japan and New Zealand.

The Year saw the conduct of two inaugural activities to raise public awareness on MTCC and the MTCS domestically. A Media Familiarisation Programme was conducted to enhance knowledge, understanding and appreciation of the local media on the critical role of the MTCS as a tool in the promotion and implementation of

sustainable forest management. The event garnered good media coverage with a total of 13 media articles. On the other hand, the first ever MTCC Photography Contest entitled "Experience Forest Experience MTCS-PEFC" attracted the participation of 95 photography enthusiasts and nature lovers. A total of 837 entries were received with scenic pictures covering the social, economic and environmental benefits of Malaysia's tropical forest. The winners were awarded their prizes and their photographs exhibited at the Kuala Lumpur Photography Festival (KLPF) held on 25 November.

Internationally, MTCC continued to participate in selected exhibitions to promote the MTCS as a credible mark for sustainable wood products. MTCC also maintained engagement with various stakeholders and participated actively in PEFC General Assembly, Members Meeting and Working Group meetings to provide feedback and local perspective into the processes, both at the policy and standard review levels. Such continuous engagement is imperative to ensure that the interest of the MTCS is safeguarded as well as to ensure that the MTCS continues to conform to international benchmarks of sustainability.

Sustainable management of forest and certification are only possible with knowledgeable and dedicated human resource. As a contribution to the efforts in increasing human resource capacity in this field, MTCC collaborated and presented MTCC Academic Awards to three undergraduates from two local universities, i.e. Universiti Putra Malaysia (UPM) and Universiti Malaysia Sabah (UMS). The aim of the award is to promote academic excellence and inculcate a love for forest among university students while strengthening engagement with academic institutions. This is in addition to the various technical trainings conducted throughout the Year for auditors, companies as well as government agencies.

My sincere appreciation goes to the MTCC Chairman, Board of Trustees and Members of MTCC, for their continued guidance and encouragement in our various endeavours in 2017. I would also like to thank the MTCC team for their commitment and hard work in making 2017 an eventful year for MTCC.



FOREST MANAGEMENT CERTIFICATION

NATURAL FOREST

In 2017 all six certified forest management units (FMUs) in Peninsular Malaysia maintained their certification after undergoing successful surveillance audits against the MC&I(Natural Forest). These were the FMUs for the states of Kedah, Negeri Sembilan, Pahang, Perak, Selangor and Terengganu. The Terengganu FMU which was previously audited by SGS (Malaysia) Sdn Bhd, was awarded with a new certificate (FMC 00115) by SIRIM QAS International in March 2017. The change in the certification body was attributed to SGS (Malaysia) Sdn Bhd's decision to discontinue its forest management certification accreditation with STANDARDS MALAYSIA.

Anap Muput FMU in Sarawak as well as Segaliud Lokan FMU and Bornion Timber Sdn Bhd (FMU 11) in Sabah also maintained their certification.

FOREST PLANTATION

On certification of forest plantation management unit (FPMU), three new certificates were awarded to Shin Yang Forestry Sdn Bhd (Kejin Long Lama FPMU), Samling Reforestation (Bintulu) Sdn Bhd (Lana FPMU) and Bornion Timber Sdn Bhd (Ulu Sg Milan & Sapulut Forest Reserve FPMU 11). Two FPMUs, namely Kuala Baram FPMU and Segan FPMU managed by Shin Yang Plywood Sdn Bhd and Samling Timber Sdn Bhd respectively have their certificates renewed following a recertification audit against the MC&I Forest Plantation.v2. Additionally, Penyuan and Masama FPMU maintained their certification following a successful surveillance audit conducted in 2017.

Details regarding the PEFC-certified FMUs and FPMUs are as shown in **Table 1** and **Table 2**, respectively.

CHAIN OF CUSTODY CERTIFICATION

In 2017, a total of 41 companies were awarded the PEFC Certificate for Chain of Custody (CoC). The Certification bodies (CBs) which issued these certificates are as shown in **Table 3**. Of these certificates, two were issued by overseas CBs namely DQS CFS GmbH and Exova BM Trada.

However, the year also saw the withdrawal and expiry of 29 certificates and the suspension of seven certificates. As a result, there was only a slight increase in the total number of PEFC Certificate for Chain of Custody from 352

ISSUANCE OF PEFC AND MTCC LOGO USAGE LICENCES

A total of 26 new logo usage licences were approved by the Notification Committee comprising 21 and 5 licences for the use of PEFC and MTCC logo respectively.

Of this number, a total of 19 licences were issued to the CoC certificate holders (Group C), 5 licences to the forest management certificate holders (Group B) and 2 licences to the certification body (Group D).

NOTIFICATION OF CERTIFICATION BODIES

Two accredited CBs were issued with PEFC notification to operate CoC certification under the MTCS namely, Platinum Shauffmantz Veritas Sdn. Bhd. and SGS Société Générale de Surveillance SA.

Platinum Shauffmantz Veritas Sdn. Bhd. was granted accreditation by STANDARDS MALAYSIA to operate CoC certification under the MTCS on 13 June 2017 and became a PEFC-notified CB on 4 July 2017.

SGS Société Générale de Surveillance SA is an existing PEFC Council-notified CB based in Switzerland. It was notified as a PEFC-notified CB under the MTCS on 11 July 2017.

With the above addition, the total number of PEFC-notified CBs operating CoC certification increased from 14 in 2016 to 16 in 2017, while that operating forest management certification declined from two in 2016 to one in 2017. Details of the PEFC notified CBs under the MTCS are as shown in **Table 4**.



EXPORT OF TIMBER PRODUCTS CERTIFIED UNDER MTCS

The export of timber products certified under the MTCS increased by 24.90% from 190,405 $\,\mathrm{m}^3$ in 2016 to 237,793 $\,\mathrm{m}^3$ in 2017. The Netherlands, United Kingdom and Germany remained the three major importing countries of the MTCS-certified timber and timber products

Sawn timber, mouldings and plywood remained as the major products exported, followed by doors, builders carpentry and joinery, furniture, finger jointed timber, veneer, furniture parts and floorings. Although sawn timber remained the dominant export commodity, its share in the overall export had dropped from 52.11% in 2016 to 49.67% in 2017, whilst that of plywood decreased from 23.03% to 17.53%. However, the share of export of moulding products jumped from 23.03% in 2016 to 28.22% in 2017.

MTCS-certified timber products were exported to six new markets namely Algeria, French Polynesia, New Caledonia, Philippines, Saint Lucia and Spain, bringing the total number of destinations importing MTCS-certified timber products to 65.

The export performance in 2017 brings the cumulative export of certified timber products to 1,610,216 m³ **[Figure 1]**. The Netherlands continued to remain as the largest contributor with import of 617,511 m³ (38.35%) of the total amount exported since July 2002.




Figure 2: Export of timber products certified under MTCS by product type, 2017

The export of certified products according to product type and destination for 2016 and 2017 are as shown in **Figures 2-5**.

Figure 1: Export of timber products certified under MTCS, July 2002 – December 2017





Figure 3: Export of timber products certified under MTCS by product type, 2016

Figure 4: Export of timber products certified under MTCS by destination, 2017





Figure 5: Export of timber products certified under MTCS by destination, 2016



CERTIFICATION STANDARDS

Review of MC&I(Natural Forest)

The 71st Meeting of the MTCC Board of Trustees held in March 2017 agreed to put on hold the review of the Malaysian Criteria and Indicators for Forest Management Certification or MC&I(Natural Forest).

The decision to defer the review took into consideration the concurrent review of the PEFC standards and technical documents, the outcome of which has a bearing on the review of the MC&I(Natural Forest). The review of the PEFC standards and technical documents was rescheduled to be completed by the end of 2017.

of the PEFC ST 2003:2012 Second Edition document, which requires all PEFC CoC auditors under MTCS to attend auditor training course once every two years.



RECOGNITION OF MTCS

PUBLIC PROCUREMENT POLICIES

In January 2017 following a Parliamentary debate, the MTCS was granted full acceptance by the Dutch Government under its Public Procurement Policy for Sustainable Timber. The recognition is an important endorsement of Malaysia's commitment and on-going efforts in promoting and implementing sustainable forestry and timber industry through certification under the MTCS.

The MTCS achieved another milestone when the Tokyo Organising Committee of the Olympic and Paralympic Games (TOCOPG) 2020 accepted the MTCS under its "Sustainable Sourcing Code for Timber" for the construction of the upcoming Tokyo Olympic facilities.

In addition, countries with active operational public procurement policies namely the United Kingdom, Germany, France, Denmark, Belgium, Finland, Switzerland and New Zealand have also accepted the MTCS.

The MTCS has also been recognised by the following:

- The Forestry Agency, Ministry of Agriculture, Forestry and Fisheries, Japan which lists MTCS in its Guideline for Verification on legality and Sustainability of Wood and Wood Products (Since April 2006)
- The Free and Hanseatic City of Hamburg, Germany which has granted full acceptance of the MTCS in its procurement policy (since December 2009)

GREEN BUILDING SYSTEM

The PEFC-endorsed MTCS continues to be recognised under the green building schemes of Australia, Italy, Singapore, Netherlands, United Kingdom, Canada, United States of America, Japan and Abu Dhabi, UAE.

The GBI in Malaysia has recognised the MTCS under its Sustainable Timber Criterion since April 2010.





PEFC RELATED ACTIVITIES

PEFC FOREST CERTIFICATION WEEK

The PEFC Forest Certification Week which included the Twenty-Second PEFC General Assembly (GA) was held in Helsinki, Finland from 13 to 17 November 2017. The event saw the largest gathering of participants to date totalling 298 comprising Members, potential Members, Stakeholders and the PEFC Secretariat.

MTCC was represented by Yong Teng Koon (CEO) and Noor Eshah Yat [Senior Manager (Administration & Finance)]. Themed "Making Certification Smart", various programmes, meetings and activities were conducted throughout the week to discuss and explore the potential and benefits of incorporating new and smart technologies in forest certification.

Members Meeting (13 – 14 November)

At this meeting, the following activities were conducted:

- (i) PEFC International staff for EU Affairs, Xavier Noyon provided an update on the current situation in Europe touching on issues related to forest law enforcement, governance and trade (FLEGT), enforcement of European Union Timber Regulation (EUTR), Green Procurement and EU Ecolabels, and EU policy on forest biomass for sustainable production of energy.
- (ii) Customer Engagement Group meeting This Working Group discussed about the need for mapping out PEFC certified packaging suppliers

- due to pressure for obtaining 100% certified packaging materials towards Global Green Packaging Market by 2020.
- (iii) Financial Working Group meeting PEFC is working towards formulating a strategy that could address the financial needs of all Members. PEFC Secretariat presented the analysis of the result from a survey conducted in October 2017 among Members and PEFC certificate holders regarding this matter. The result showed that all NGBs spent the bulk of their income towards paying PEFC Membership fee, staff salaries and marketing.
- (iv) Members were updated on the formulation of the PEFC 2018-2022 Strategies. The meeting deliberated on the revised Vision and Mission statements as well as the various proposed strategies to position PEFC as a thought leader on sustainable forestry, including the sustainable development goals through increasing and more effective communication, focused engagement and innovative approaches. The revised document will be presented for the consideration of the Members Meeting scheduled in April 2018.
- (v) PEFC Unit Heads presented updates on their respective portfolios, covering standards review, communications, marketing, projects & developments, as well as their proposed plan and activities for 2018.

PEFC GENERAL ASSEMBLY (15 NOVEMBER)

The 22nd PEFC GA was officially opened by the Minister of Agriculture and Forestry of Finland, Jari Leppä. The Minister iterated the global importance of sustainable forest management and congratulated PEFC on its contribution towards this development.

The GA was also attended by Rosalie Matondo, the Minister of Forestry of the Republic of Congo. The Republic of Congo is a new member of PEFC.

The GA saw the resignation of Sheam Shatkuru Grazella as the Vice Chair of the PEFC Board, following her resignation from the Malaysian Timber Council (MTC) to

join the International Tropical Timber Organisation (ITTO) with effect from 1 November 2017.

The representatives from Croatia, Kenya, Myanmar, Philippines and Vietnam expressed intention to become new members of PEFC.

The Indonesian Forestry Certification Cooperation (IFCC) was awarded the "Certificate of Appreciation" by PEFC for having achieved the biggest increase in PEFC-certified forest area, while the Sustainable Green Ecosystem Council (SGEC) of Japan the biggest growth in PEFC Chain of Custody certificates.

STAKEHOLDER DIALOGUE (16 NOVEMBER)

PEFC Stakeholder Dialogue in progress



PEFC Stakeholder Dialogue 2017 focused on the theme of "Making Certification Smart", exploring and discovering new emerging technologies which show promise for supporting forest certification.

The Stakeholder Dialogue saw the active participation from forest sector stakeholders, leading technology providers, innovators and sustainability experts to exchange views on what is needed, what is working and where are the opportunities for scaling up application.

The keynote address entitled "Embracing technology innovation within certification: What's the hype?" was delivered by Wiebke Herding, Managing Director of ON:Subject. The presentation highlighted current needs, explored and identified future directions and potential

impacts, providing a common framework to facilitate further discussion throughout the day.

Three parallel workshops were conducted as follows:

- (i) SMART solutions for strengthening trust and traceability throughout value chains;
- (ii) SMART solutions for engaging and leveraging society for sustainable forestry; and
- (iii) Smart solutions for activating efficient and accessible sustainable forest management certification.

Under Workshop (iii), Khairul Najwan Ahmad Jahari from SIRIM QAS International Sdn Bhd, a MTCS-notified certification body shared his experience of piloting the use of drones in better identifying spots and facilitating on the ground auditing in Malaysia.

FIELD TRIP (17 NOVEMBER)

The field trip brought the participants to Jyväskylä, central Finland which is about 300 km from Helsinki. The forest excursion took place in Jari Penttinen's forest to witness the use of smart technologies in forest management and harvesting. The representatives from the Forest Management Associations of Finland briefed participants on the implementation of sustainable forest management and regional group certification in Finland.

After the forest excursion, the participants visited the Metsä Group Bioproduct Mill in Äänekoski. This new mill that began operation in August 2017 is regarded the world's first next-generation bioproduct mill designed to be resource efficient, generating zero waste during its operation. The mill does not consume any fossil fuel but generates its own bioenergy from byproducts through the production of softwood and birch pulp for board, tissue, orienting paper and other specialty products.

Briefing on Forest Management Practices



PEFC WORKING GROUP MEETING

MTCC continued to participate actively in three working groups (WG) under the PEFC Standard revision process. This process began in the middle of 2016 and is expected to be completed in 2018.

The WG1 on Sustainable Forest Management which focused on the revision of Sustainable Forest Management – Requirements (PEFC ST 1003:2010) met twice in 2017. The first meeting was held in Geneva, Switzerland from 27-29 March and the second meeting held in Hamburg, Germany from 4-6 September. MTCC also participated in the Task Force on Conversion under the WG1. which met via online conference on 14 June, 27 July and 7 December.

MTCC is also a member of WG2 on Group Forest Management which is tasked to review two standards namely Group Forest Management Certification – Requirements (PEFC ST 1002:2010) and Forest Management Certification Procedures (PEFC ST 1004).

The meeting was held back to back with the WG1 meeting from 23-24 March in Geneva and the second meeting on 7-8 September in Hamburg.

WG4 on Chain of Custody and Labelling met twice at PEFC office in Geneva on 25-26 January and on 28-29 August to further deliberate the revision of the two CoC standards as well as the labelling standard. MTCC also participated in the webinar held on 5-6 April 2017.

At the end of 2017, PEFC had approved two revised technical documents, namely GD 1007:2017 Endorsement and Mutual Recognition of National Systems and their Revision (approved on 6 October 2017) and PEFC ST 1001:2017 Standard Setting – Requirements (approved on 15 November 2017). MTCC participated in a webinar held on 30 November 2017 on the approved PEFC ST 1001:2017 Standard Setting – Requirements.

COOPERATION

TWENTIETH MEETING OF THE ASEAN WORKING GROUP ON FOREST PRODUCTS DEVELOPMENT

MTCC as the lead agency for the Working Group on a Pan ASEAN Timber Certification Initiative (WG-PATCI) attended the 20th Meeting of the ASEAN Working Group on Forest Products Development (AWG-FPD) as the WG-PATCI and the ASEAN Experts Group on Herbal and Medical Plants (AEG-HMP) had now been subsumed under the AWG-FPD following the decision of the 18th ASOF Meeting held in 2015.

Held from 24 – 25 July in Putrajaya, the Meeting gathered delegates from Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Myanmar, Philippines, Thailand, and Viet Nam. Representatives from the European Union Forest Law Enforcement and Governance and Trade (EU-FLEGT) Facility, International Network for Bamboo and Rattan (INBAR), and the ASEAN Secretariat were also present at the Meeting.

The AWG-FPD aims to enhance ASEAN cooperation in forest products development and the alignment of national standards and testing protocols in accordance

with International Standard; enhance intra and extra-ASEAN trade and competitiveness of ASEAN forest products including through inter-alia timber certification; support the development of medicinal and aromatic plant industries, and promote co-operation with ASEAN Dialogue Partners, regional and international organizations and the private sector in marketing and image building for ASEAN forest products.

The 12-member delegation from Malaysia comprised representatives from the Ministry of Natural Resources and Environment (MNRE), Department of Wildlife and National Parks (PERHILITAN), Forest Research Institute Malaysia (FRIM), Malaysian Timber Industry Board (MTIB), Malaysian Timber Council (MTC), MTCC and the Protem Secretariat of the Malaysia-EU FLEGT VPA. MTCC was represented by its CEO and Melvin Ku, Senior Executive (Forest Management). The Meeting was chaired by Dr. Megat Sany bin Megat Ahmad Supian from the MNRE and assisted by Tint Swe from Myanmar.

The ASEAN Member States (AMS) provided an update on the progress of implementation of Criteria and Indicators (C&I) for legality of timber (or) forest management certification (and/or) implementation of timber certification and legality assurance systems and ASEAN Chain of Custody Guidelines in their respective countries. MTCC presented a Malaysian Country Progress Report on Forest Management and Chain of Custody Certification under the MTCS at the meeting. Currently, among the AMS, only Malaysia and Indonesia have an operational national timber certification scheme. Cambodia, Thailand, the Philippines and Viet Nam are in the process of developing their national timber certification systems.

The AMS viewed the importance of supporting trade facilitation of timber and timber products through the development of mutual recognition agreement (MRA) and agreed to the conduct of a "Study on stepwise approach towards MRA for timber legality in ASEAN" supported by the EU-FLEGT Facility.

The draft Plan of Action (PoA) for ASEAN Cooperation in Forest Products Development which is based on the Strategic Plan of Action (SPA) for ASEAN Cooperation in Forestry (2016-2025) was considered by the Meeting. The PoA consists of three strategic thrusts i.e. (i) enhancing sustainable forest management, (ii) enhancing trade facilitation, economic integration and market access, and (iii) institutional strengthening and human resources development. Six action programmes and 22 activities were agreed by the AMS for it to be submitted for the endorsement of the 20th ASEAN Senior Officials on Forestry (ASOF) Meeting.

The Meeting also noted the proposal for partnership between INBAR and ASEAN where 6 AMS are members of INBAR namely Indonesia, Malaysia, Myanmar, Philippines, Thailand and Viet Nam.



SIGNIFICANT EVENTS

PRESENTATION OF CoC CERTIFICATES

In 2017, MTCC undertook new public relation initiatives to raise awareness of local consumers on the availability of MTCS-certified timber products. MTCC leveraged on the award of Chain of Custody to local iconic brands to further raise the visibility and profile of the MTCS in the local market. Towards this end, MTCC organised special events for the award of the Chain of Custody certificates to the manufacturers of the following brands:

i. Royal Selangor

YB Datuk Seri Mah Siew Keong, the Minister of plantation Industries and Commodities presented the Chain of

Custody (CoC) certificate to Royal Selangor on 9 August 2017. Royal Selangor is an iconic brand for pewter products and is the first non-wood based company to obtain CoC certification under the MTCS.

This CoC certification enables Royal Selangor to label all its certified wood-based pewter with MTCC / PEFC label which will further strengthen Royal Selangor's global presence.

This positive development would help encourage the use of certified timber beyond the traditional woodbased companies while contributing to the promotion of sustainable forest management.




