The Malaysian Timber Certification Council (MTCC) is an independent organisation and commenced its operations in January 1999 to develop and operate the voluntary Malaysian Timber Certification Scheme (MTCS). MTCC was incorporated under the Companies Act 1965 as a company limited by guarantee and is governed by a Board of Trustees.

As the national governing body (NGB), MTCC is responsible for the implementation of the MTCS to carry out the following main activities:

- support the standard-setting process by serving as the secretariat to the appropriate standard setting body in formulating standards related to timber certification and keeping them under review periodically
- process applications for MTCS notification of certification bodies (CBs) operating forest management system and/or chain of custody (CoC) certification, and the issuance of logo usage licences to certificate holders
- implement the procedure for the investigation and resolution of disputes, complaints and appeals related to its role as the NGB
- liaise closely with the national accreditation body and other certification organisations in matters related to timber certification
- coordinate with national, regional and international bodies related to timber certification to facilitate cooperation and mutual recognition arrangements
- conduct programmes to promote and publicise the MTCS, both locally and internationally.









ANNUAL GENERAL MEETING

The Nineteenth Annual General Meeting was held on 13 September in Kuala Lumpur during which the Audited Accounts for the Financial Year ended 31 December 2017, Reports of the Trustees and Auditors, and the Annual Report for the Year 2017, were tabled and adopted by the Members.

On behalf of the Board of Trustees of the Malaysian Timber Certification Council (MTCC), I am pleased to present the Annual Report and the Audited Accounts of the Council for the financial year ending 31 December 2018.

The Year 2018 has been a significant year with new experiences for both Malaysia and MTCC. The Year saw for the first time in 60 years the formation of a new Government coalition in Pakatan Harapan after the Fourteenth General Election and consequently the appointment of YB Puan Teresa Kok and YB Datuk Seri Shamsul Iskandar Haji Mohd Akin on 2 July as the Minister and Deputy Minister of Primary Industries respectively. MTCC was privileged to brief both the Minister and Deputy Minister on the role and functions of the MTCC and the operation of the Malaysian Timber Certification Scheme (MTCS) at the Ministry of Primary Industries (MPI) on 17 July. MTCC looks forward to working closely with both of them to advance Malaysia's aspirations and goals for sustainable forest management and certification.

MTCC also wishes to place on record our appreciation to Datuk Seri Mah Siew Keong and Datuk Datu Nasrun Datu Mansur for their strong support of our work during their tenure as the Minister and Deputy Minister of Plantation Industries and Commodities.

In 2018, it was heartening for me to note a significant increase of six (6) new forest management units (FMUs) certified under the MTCS. It was even more heartening that all these FMUs were from Sabah and Sarawak, with Sarawak coming up top with five (5) FMUs and the remaining one in Sabah. To me this is an exciting development as the uptake for forest certification has always been in the Peninsula since the operation of the MTCS in 2001. The above development signals the growing interest and greater acceptance of forest certification in Sabah and Sarawak which augers well with the growing demand for certified sustainable timber products by the international markets. In this connection, MTCC would like to congratulate the State Government of Sarawak for taking a very bold step in 2018, mandating all long-term timber licence areas to obtain forest certification latest by 2022. Without a doubt, the mandate of the Sarawak State Government is the single contributing factor that has resulted in the increase of number of certified FMUs in Sarawak.

I am also happy to note a significant increase in the export of MTCS-certified timber products from 237,792.60 m3 in 2017 to 348,801.57 m3 in 2018, an increase of 46.6%.


One significant event conducted by MTCC was the MTCC Strategic Planning Workshop held on 22-24 October in Port Dickson. The Workshop was attended by members of the MTCC Board and key stakeholders who have been involved in the MTCS processes, comprising of representatives from the social and environmental non-government organisations, workers' unions, timber trade associations and relevant government agencies. The primary aim of the workshop was to exchange views and obtain feedback from the key stakeholders that will feed into planning and charting the future directions of MTCC, including the review of its Vision and Mission, noting that MTCC will enter into its 20th year of operation in 2019.

One other significant event facilitated by MTCC was the meeting between YB Minister and the Chairman of PEFC International, Mr. Peter Latham on 18 October. The meeting provided the forum for Mr. Latham to brief the Minister on the latest international developments related to certification and exchange views on forestry related matters.

In 2018, besides the routine work of monitoring forest management and chain of custody certification, and conducting various activities to promote the MTCS, MTCC has resumed the review of the MC&I(Natural Forest) standard and participated actively in both regional and international forums related to forest certification in particular PEFC related activities. MTCC has also contributed towards the adoption of the PEFC SFM standard by the PEFC General Assembly in November.

My congratulations to the MTCC management team and supporting staff for their dedication and hard work for the above achievements and the continued international recognition and acceptance of the MTCS.

In conclusion, I would like to appreciate my predecessor Datuk Himmat Singh for his dedication and significant contributions to the organisation during his 2-year tenure as the Chairman of the MTCC Board. I would also like to place on record my appreciation to YB Puan Teresa Kok for the trust given in appointing me as the new Chairman with effect from 27 July 2018.



The extent of certified forests under the MTCS increased from 4.12 million hectares in 2017 to 4.59 million hectares in 2018. The increase was attributed to the addition of six new forest management units (FMUs), bringing the total number of FMUs to 15, in addition to the six existing certified forest plantation management units (FPMUs). The year saw MTCC resume the review of the MC&I (Natural Forest) standard in July following a one-year break to be in tune with the timelines of the review of the PEEC SEM standard.

For chain of custody certification (CoC), a total of 39 new certificates were issued in 2018. However, as a result of the withdrawal and expiry of 35 certificates and the suspension of one certificate, the net increase was only three certificates. The total number of CoC certificate holders as of December 2018 stands at 360.

In terms of export, the export volume of timber products certified under the MTCS showed a significant increase of 46.6% from 237,793 m3 in 2017 to 348,801 m3 in 2018. The Netherlands still led in terms of market share, despite decreasing from 36.4% in 2017 to 20.82% in 2018, followed by Denmark at 18.22% and the United Kingdom at 13.79%. Brunei and East Africa became the latest two new destinations for the MTCS-certified timber products in 2018.

In terms of promotional activities, MTCC conducted the second edition of the MTCC Photography Contest entitled "Experience Forest Experience MTCS-PEFC" which resulted in the submission of a total of 990 entries with scenic pictures covering the social, economic and environmental aspects of Malaysia's tropical forest. The contest included a new short video category to showcase the power of videography to spark human emotion and connection to forests. The photographs of the winners were exhibited at the Kuala Lumpur Photography Festival (KLPF) held on 26-28 October. Other promotional activities included participation in selected exhibitions to promote the MTCS as a credible mark for sustainable wood products both domestically and internationally.

As the MTCS is a PEFC-endorsed scheme, MTCC participated actively in relevant PEFC activities and was involved in the PEFC Working Groups on standard review for both forest management and chain of custody certification, PEFC Members Meeting as well as the PEFC Forest Certification Week and General Assembly. MTCC's participation is important to ensure that the voice

of developing tropical countries is heard, the interest of the MTCS is safeguarded and the MTCS continues to meet international benchmarks of sustainability.

Noting that the sustainability of the future lies in the hands of the future generations, MTCC has been intentional in the conduct of our awareness activities to reach out to the university students. In this regard, the MTCC Academic Award presented to three undergraduates from two local universities, i.e. Universiti Putra Malaysia (UPM) and Universiti Malaysia Sabah (UMS) was aimed at promoting academic excellence and inculcating a love for forest among university students while strengthening our engagement with the academic institutions. The Education Talk to the architectural students at Tunku Abdul Rahman University College (TARUC) and UPM was aimed at encouraging the budding architects to appreciate wood and to embrace sustainability in their designs by prescribing the use of certified timber. This is in addition to the various technical trainings conducted throughout the year for auditors, companies as well as government agencies.

MTCC is grateful for the continued cooperation and support from the forest managers, timber companies, certification bodies, accreditation body, the forestry and timber-related agencies and representatives of the environmental, social and economic stakeholder groups in Sabah, Sarawak and Peninsular Malaysia towards its activities and initiatives in 2018, in particular the review of the MC&I(Natural Forest). MTCC looks forward to continue working with all parties concerned to achieve the common objective of sustainably managing our forest resources.

I am grateful to the Chairman and Board of Trustees, as well as the Members of MTCC, for their continued guidance and support. In this regard, I would like to express my deepest appreciation to Datuk Himmat Singh for his leadership, wise counsel and guidance during his two-year tenure as the MTCC Chairman from 16 May 2016 to 15 May 2018. I would also like to extend a warm welcome to Datuk K. Yogeesvaran, the new Chairman of MTCC. I look forward to working closely with him to advance the national sustainability agenda through the MTCS.

Last but not least, my sincere appreciation to the MTCC team for their commitment and hard work in making 2018 an eventful year for MTCC.







FOREST MANAGEMENT CERTIFICATION

NATURAL FOREST

In Peninsular Malaysia, five forest management units (FMUs) maintained their certification after undergoing successful surveillance audits against the requirements of the MC&I(Natural Forest) in 2018. These were the FMUs for the states of Kedah, Pahang, Perak, Selangor and Terengganu. The Negeri Sembilan FMU renewed its certification on 28 December 2018 after undergoing a successful recertification audit conducted by SIRIM QAS International Sdn. Bhd.

In Sarawak, five new certificates were awarded in 2018 as follows:

- i) Ravenscourt Sdn. Bhd. (Ravenscourt FMU) on 4 June,
- ii) Tanjong Manis Holdings Sdn. Bhd. (Kapit FMU) on 11 June,
- iii) Shin Yang Trading Sdn. Bhd. (Linau FMU) on 16 July,
- iv) Syarikat Samling Timber Sdn. Bhd. (Ulu Trusan FMU) on 19 December and
- v) Jaya Tiasa Holding Sdn. Bhd. (Bahau Kahei FMU) on 19 December.

Additionally, Anap Muput FMU maintained its certification after undergoing a successful surveillance audit.

In Sabah, a new certificate was awarded to Sapulut Forest Development Sdn. Bhd. (FMU14) on 11 June 2018. KTS Plantation Sdn. Bhd. (FMU 19B) renewed its certificate on 2 December after a successful recertification audit, while Bornion Timber Sdn. Bhd. (FMU 11) maintained its certification following a successful surveillance audit.

In total, 15 FMUs covering 4,491,269.84 ha of natural forest have been certified under the MTCS as of 31 December 2018 **(Table 1)**.

FOREST PLANTATION

For certification of forest plantation management unit (FPMU), six FPMUs, namely Bornion Timber, Segan, Masama, Penyuan, Kejin Long Lama and Lana FPMU maintained their certification following successful surveillance audits against the requirement of the MC&I Forest Plantation.v2 in 2018. However, Shin Yang Plywood Sdn Bhd (Kuala Baram FPMU) had decided to withdraw and discontinue its certification on 5 October 2018. The total extent of certified forest plantations amounts to 101,030 ha (Table 2).

EXPORT OF TIMBER PRODUCTS CERTIFIED UNDER THE MTCS

The export of timber products certified under the MTCS had increased significantly by 46.6% from 237,792.60 m³ in 2017 to 348.801.57 m³ in 2018.


Sawn timber was the major product exported, with the overall export grew from 49.67% in 2017 to 50.64% in 2018, followed by moulding products accounting for 17.74% and plywood 17.57% (Figures 1 and 2).




Figure 3: Export of timber products certified under MTCS by destination, 2018




Figure 4: Export of timber products certified under MTCS by destination, 2017

The Netherlands continued to be the major importing country of the MTCS-certified timber and timber products followed by Denmark and the United Kingdom accounting for 20.82%, 18.22% and 13.79% respectively of the total export in 2018. Brunei and East Africa were two latest destinations, bringing the total number of countries importing MTCS-certified timber products to 66 since the operation of the MTCS in 2001 (Figures 3 and 4).





Figure 5: Export of timber products certified under MTCS, July 2002 – December 2018

The export performance in 2018 brings the cumulative export of MTCS-certified timber products to 1,959,052.82 m³ (Figure 5).

Figure 2: Export of timber products certified under MTCS by product type, 2017

CERTIFICATION STANDARDS

Review of MC&I(Natural Forest)

The 75th Meeting of the MTCC Board of Trustees held on 6 March 2018 agreed to resume the review of the Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest) or MC&I(Natural Forest) which had been put on hold in 2017. The decision was made taking into consideration the review of the PEFC sustainability benchmark is expected to be completed by the end of 2018.

Following the above decision, the Third Meeting of the Standards Review Committee (SRC) was held from 17-18 July 2018 in Port Dickson, Negeri Sembilan. The Meeting continued deliberation on the working draft that has streamlined the requirements of the MC&I(Natural Forest) and MC&I Forest Plantation.v2 into a single document.

The Meeting also deliberated on the proposal to restructure the standard based on three possible options:

- i) To restructure the standard according to the ISO High Level Standard, or
- ii) To maintain the existing structure with updated requirements, or
- iii) To maintain the structure and incorporate Principle 10 of the MC&I Forest Plantation.v2 into the relevant Criteria and Indicators of Principle 1 to 9 of the streamlined standard.

Following deliberation, the Meeting agreed to maintain the existing structure while exploring the feasibility of incorporating the requirements of Principle 10 into the relevant Criteria and Indicators of Principles 1 to 9 for forest plantations.







TRAINING ON THE REQUIREMENTS OF THE MTCS

1. Auditor Training Course on Forest Management Certification

MTCC conducted two auditor training courses covering MC&I(Natural Forest) and MC&I Forest Plantation.v2 on 9 – 12 July in Kuantan, Pahang and on 3 – 7 September in Lawas, Sarawak. The training course aimed to equip potential auditors with the necessary knowledge and skills to conduct forest management certification audit, as well as to fulfill the competency requirements for accreditation by STANDARDS MALAYSIA.

The four-day auditor training course held in Kuantan was conducted in collaboration with the Forestry Department Peninsular Malaysia (FDPM) and attended by a total of 19 participants from Certification Bodies, FDPM, Forest Department Sarawak and WWF-Malaysia. The field audit training was conducted at Lepar Forest Reserve, Pahang FMU.

2. Peer Reviewer Training

Peer reviewers are independent experts appointed to review forest management certification audit reports prepared by the certification bodies to ensure that the audit has been conducted professionally and in compliance with the requirements of the certification standard.

A one-day peer reviewer training on the MTCS was conducted on 8 November at the MTCC office to familiarise potential peer reviewers on the requirements of MC&I(Natural Forest) and MC&I Forest Plantation. v2 standards. A total of seven participants attended the training which was conducted by MTCC Senior Manager (Forest Management), Siti Syaliza.

3. Capacity Building Training Course

In addition to conducting requisite training courses, MTCC also collaborates with relevant agencies and organisations on capacity building programmes for their employees and contractors. Two training courses were conducted in Sarawak in support of the commitment by the State Government to achieve full certification by 2022.

In collaboration with Sarawak Forestry Corporation (SFC), a five-day training course was conducted from 29 October to 2 November in Sibu, Sarawak. A total of 45 participants from SFC and FMU Licence Holders attended the course which included a one-day field audit training held at the Kapit FMU, an MTCS-certified FMU since 2018.

A two-day training course on forest management certification was also conducted from 29 to 30 October in Kuching for 33 participants from Sarawak Timber Industry Development Corporation (STIDC) and FMU Licence Holders.







4. Auditor Training Course on PEFC **Chain of Custody Certification**

MTCC organised a two-day Auditor Training Course on PEFC Chain of Custody (CoC) Certification under the MTCS on 19 to 20 December in Kuala Lumpur.

The course was conducted to train new CoC auditors so that they are familiar with the requirements of the PEFC ST 2002:2013 Chain of Custody of Forest Based Products - Requirements. The course was conducted to fulfill the training requirement for auditors as stipulated in para 6.1.1.2.2 of the PEFC ST 2003:2012 Requirements for Certification Bodies operating Certification against the PEFC International Chain of Custody Standard document. Six participants from three Certification Bodies and two participants from STANDARDS MALAYSIA attended the training course.

5. Briefing on Chain of **Custody Certification**

MTCC conducted chain of custody briefings to three CoC certificate holders at their facilities. The briefing for Tandem Holdings Sdn. Bhd., Setia-Wood Industries Sdn. Bhd. and Robin Resources Sdn. Bhd. focused on the implementation of the due diligence system (DDS) as stipulated under the PEFC ST 2002:2013 standard.

To encourage more timber companies to embrace certification, MTCC also conducted briefings for non-CoC certificate holders i.e. Gayador Sdn. Bhd., Gaya Murni Sdn. Bhd. and MUKK. These briefings were requested by the companies to provide their staff with a better understanding and familiarisation with the requirements of the PEFC ST 2002:2013 standard.

Qualified Trainer Programme under PEFC

The PEFC Qualified Trainer Programme (QTP) is a programme to enable PEFC National Governing Body Members to become qualified trainers for conducting national PEFC Chain of Custody Auditor Training recognised by PEFC International at the national level. The programme also aims to ensure the harmonization of training in terms of quality and content as well as helps to bring all members to the same level of knowledge.

Upon her successful completion of the PEFC QTP MTCC Manager (Product), Sabrina Mawasi was awarded with a certificate on 15 November 2018 that qualifies her to conduct PEFC Chain of Custody auditor training recognised by PEFC at both national and international levels.

As part of the capacity building programme, MTCC Senior Executive (Product), Akmal Saarani participated in the PEFC QTP programme conducted in Geneva on 23-24 April. Akmal is scheduled to complete his programme in 2019 and is required to participate in two field audits of CoC certification.



INDUSTRIAL TALK

Believing in the crucial role of architects in specifying the use of wood in designing and constructing building, MTCC in collaboration with Ar. Azman Zainal conducted a talk with members of the Malaysian Institute of Architects (PAM) under their Continuing Professional Development programme on how the use of "good wood" in built structures could provide benefits to personal well-being, society and the environment.

The talk given on 17 November was attended by 78 PAM members. Besides sharing the roles and function of

Timber is a renewable, versatile and aesthetically appealing building material that architects should capitalise on to design creative sustainable living solutions. Currently, wood has been used mainly as form works in construction. Through the education talk, we hope to spark the imagination of aspiring architects to use timber and in particular MTCS-certified timber beyond the form works stage, but as building material, be it for structure or interior decoration. In this age when the world is so concerned about the impact of climate change due to greenhouse gases (GHG) emission, the use of more wood in building would enable more carbon to be locked in the buildings throughout their life time. This would also contribute to our national effort to reduce GHG emission in line with our commitment made at the Paris Agreement.

Wood is the most environmentally friendly material. It's easy to use and shape than cement. More importantly, it is also a healthier choice as wooden homes have been proven to contribute towards the wellness and well-being of people dwelling within.







RECOGNITION OF MTCS

PUBLIC PROCUREMENT POLICIES

Countries with active operational public procurement policies namely the United Kingdom, Germany, France, Denmark, Belgium, Finland, Switzerland, New Zealand and The Netherlands have accepted the PEFC-endorsed MTCS. The recognition is an important endorsement of Malaysia's commitment and on-going efforts in promoting and implementing sustainable forestry and timber industry through certification under the MTCS.



The MTCS has also been recognised by the following:

- The Forestry Agency, Ministry of Agriculture, Forestry and Fisheries, Japan which lists MTCS in its Guideline for Verification on Legality and Sustainability of Wood and Wood Products (Since April 2006)
- The Free and Hanseatic City of Hamburg, Germany which has granted full acceptance of the MTCS in its procurement policy (Since December 2009)

GREEN BUILDING SYSTEM

The PEFC-endorsed MTCS continues to be recognised under the green building scheme of Australia, Italy, Singapore, The Netherlands, United Kingdom, Canada, United States of America, Japan and Abu Dhabi, UAE.

The GBI in Malaysia has recognised the MTCS under its Sustainable Timber Criterion since April 2010.









PEFC-RELATED ACTIVITIES



As the National Governing Body for the implementation of the MTCS, which is a PEFC-endorsed scheme, MTCC participates actively in PEFC-related activities which included the PEFC Members Meeting, Technical Working Group meetings for both forest management and chain of custody, as well as the PEFC Annual General Assembly. Participation in these meetings is crucial to ensure that any decisions on PEFC's policy, technical and guidance documents, and other administrative issues, take into

account the challenges and constraints faced by the MTCS.

Participation in the above meetings have also provided MTCC the avenue and forum for more interaction, communication and sharing of experiences between national PEFC members, as well as between PEFC International and the national members on any important issues that need further deliberation/clarification.

PEFC MEMBERS MEETING

MTCC CEO and Senior Executive (Product). Akmal Saraani participated in the PEFC Members Meeting held in Geneva on 25 – 27 April. Members were updated by PEFC Secretariat on matters related to EU affairs, standards revision for both forest management and chain of custody, a special update on the proposed Trees Outside Forests

standard, the new PEFC Communication Guideline, as well as discussion on how to increase PEFC market's acceptance and share. Additionally, Members deliberated at length with regard to the proposed PEFC Strategy 2018 – 2022 which will be presented for adoption by the General Assembly scheduled in November.

PEFC FOREST CERTIFICATION WEEK AND GENERAL ASSEMBLY

The PEFC Forest Certification Week was held in Geneva, Switzerland from 12 to 16 November which included the 23rd General Assembly (GA) of the PEFC Council held on 14 November.

Themed "Moving Forward Together", various programmes and activities were conducted to explore ways to see how PEFC Members can work together as a global team, collaborating and supporting each other to strive towards PEFC's new vision of "A world which values the full contributions of sustainable forest."

One key highlight of the meeting was the adoption of the new three-pronged PEFC Strategy 2018 – 2022 to achieve the new Vision of PEFC.

The three strategic pathways identified are: (a) Increasing communications effectiveness; (b) Focused engagement; and (c) Driving innovation. Each NGB has been requested to embrace these three strategic pathways in the respective national strategies and to report annually on its progress to PEFC as a measure of the joint performance towards this global endeavour.



PEFC General Assembly in progress



The 23rd PEFC General Assembly were attended by 41 National Members and 11 international Stakeholders Members. The GA made the following key decisions:

- (i) Approved the Budget and Membership Fees for 2019. Under the approved budget, MTCC is required to pay a total of 93,750 CHF which is a slight decrease of 486 CHF as compared to the budget for 2018.
- (ii) Approved the revised PEFC ST 1003:2018 Sustainable Forest Management – Requirements, and PEFC 1002:2018, Group Forest Management Certification – Requirements. While congratulating the Working Group and the Board in achieving consensus on

the standard, Malaysia expressed caution that PEFC would need to revisit several issues surrounding conversions including the cut-off-date, for flexibility to ensure sustainable livelihoods and development are in line with national plans in developing countries. Malaysia therefore welcomed the announcement by PEFC Board on the creation of a permanent working group on sustainable forest management standard which would allow for ongoing consideration of these challenges.

(iii) Agreed to hold the 24th PEFC GA in Wurzburg, Germany on 13 November 2019.

PEFC TECHNICAL WORKING GROUP MEETING

MTCC continued to participate actively in three working groups (WG) under the PEFC Standard revision process, represented by Siti Syaliza as member for WG1 and WG2 and Sabrina for WG4.

WG1 on Sustainable Forest Management which focused on the revision of Sustainable Forest Management – Requirements (PEFC ST 1003:2010) met two times in 2018. Both meetings were held in Geneva, Switzerland on 21-23 March and 25-26 July.


WG2 on Group Forest Management was tasked to discuss the revision of two standards namely Group Forest Management Certification – Requirements (PEFC ST 1002:2010) and Forest Management Certification Procedures (PEFC ST 1004:). The members of this WG met twice in 2018. The first meeting on 23 January was held via online conference while the second meeting was

held back to back with the WG1 meeting on 26 – 27 March in Geneva.

WG4 on Chain of Custody and Labelling was tasked to discuss the revision of: (i) Chain of Custody of Forest Based Product – Requirements (PEFC ST 2002:2013), (ii) PEFC Logo Usage Rules – Requirements (PEFC ST 2001:2008), and (iii) Chain of Custody of Forest Based Product – Guidance for Use. The first meeting of the WG was held at the PEFC office in Geneva on 24 – 25 January while the second meeting was conducted via a webinar on 19 – 20 September.

At the end of 2018, PEFC ST 1002:2018 Group Forest Management Certification – Requirements and PEFC ST 1003:2018 Sustainable Forest Management – Requirements were approved by the PEFC General Assembly on 14 November.





COOPERATION



MTCC continued to provide support in advancing sustainable forest management through timber certification in the region by participating in a number of ASEAN-related meetings and workshops as follows:

Thirty Fourth Meeting of the ASEAN Consultative Committee for Standards and Quality (ACCSQ) Working Group on Conformity Assessments

The Working Group 2 on Conformity Assessments under the ASEAN Consultative Committee for Standards and Quality (ACCSQ) mainly covers matters on institutional capacity building of the accreditation bodies as well as their accredited conformity assessment bodies. The 34th Meeting of the ACCSQ WG 2 was held from 5 – 7 March in Putrajaya. Represented by MTCC Senior Manager (Forest Management), Siti Syaliza, MTCC participated in the meeting to provide support to the Malaysian delegation. Siti also presented a proposal on a Training Programme for a Forestry Certification Capacity Building for Future Cooperation on behalf of PEFC. The meeting approved the proposal for a conduct of a training by PEFC to be held back to back with the subsequent meeting of the ACCSQ WG2.

2. Regional Workshop on Finalisation of the Manual for FLEG Implementation in ASEAN

The Regional Workshop on Finalisation of the Manual for FLEG Implementation in ASEAN was held on 22 May 2018 in Pakse, Champasack Province, Lao PDR. Melvin Ku, Senior Executive (Forest Management) represented MTCC at the workshop.

The Manual for Assessing Forest Law Enforcement and Governance (FLEG) Implementation in ASEAN Member States is one of the key deliverables under the ASEAN Cooperation in Food, Agriculture and Forestry for the year 2018. The manual aims to guide those responsible for compiling data on FLEG implementation and how the required information should be assembled and presented.

3. Fourteenth Meeting of the ASEAN Working Group on Forest Management

MTCC participated in the Fourteenth Meeting of the ASEAN Working Group on Forest Management (14th AWG-FM) held from 23 – 24 May 2018 in Pakse, Champasack Province, Lao PDR. The AWG-FM aims to support ASOF and the ASEAN Ministers on Agriculture and Forestry (AMAF) in decision making by providing specific policy-oriented research results and policy analysis on forest management; support the implementation of the strategic thrusts, action programmes and activities identified in the Strategic Plan of Action for ASEAN Cooperation in Forestry, 2016 – 2025, and the Work Plan for Forest Law

Enforcement and Governance (FLEG) in ASEAN, 2016 – 2025, through the Strategic Plan of Action for ASEAN Cooperation in Forest Management developed by the Working Group; and promote sustainable forest management of all types of forest, including protection, restoration, afforestation and reforestation, and increase efforts to prevent forest degradation.

The four-member delegation from Malaysia comprised representatives from the Ministry of Water, Land and Natural Resources (KATS), Forestry Department Peninsular Malaysia (FDPM), Sabah Forestry Department and MTCC, represented by Melvin Ku, Senior Executive (Forest Management).

4. Twenty First Meeting of the ASEAN Working Group on Forest Products Development

Held from 9 – 10 July in Nay Pyi Taw, Myanmar, the 21st Meeting of the ASEAN Working Group on Forest Products Development (AWG-FPD) gathered delegates from Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Myanmar, Malaysia, Philippines, Thailand and Vietnam. The three-member delegation from Malaysia comprised representatives from the Malaysian Timber Industry Board (MTIB) and MTCC. MTCC was represented by Senior Executive (Product), Akmal Saarani.

The AWG-FPD aims to enhance ASEAN cooperation in forest products development and the alignment of national standards and testing protocols in accordance with international standard; enhance intra- and extra-ASEAN trade and the competitiveness of ASEAN forest products including through inter-alia timber certification; support the development of medicinal and aromatic plant industries, and promote cooperation with ASEAN Dialogue Partners, regional and international organisations and the private sector in marketing and image building for ASEAN forest products.

The meeting noted the progress reports and recommendations of the working groups under the ASOF, namely the ASEAN Working Group (AWG) on Forest Products Development; AWG CITES and Wildlife Enforcement; AWG Social Forestry; AWG Forest Management; and AWG Forests and Climate Change. Dialogue/development partners which cooperate with AMS also provided updates on the collaboration activities and proposals for future activities.




6. Forestry Certification Capacity Building for Future Cooperation

MTCC participated in the Forestry Certification Capacity Building for Future Cooperation under the ASEAN Consultative Committee on Standards and Quality ACCSQ Working Group 2 (ACCSQ WG2) – Working Group on Accreditation and Conformity Assessment held on 2 October 2018 in Vientiane, Lao PDR. MTCC provided support to PEFC in the conduct of the programme and was represented by Senior Manager (Forest Management), Siti Syaliza and Executive (Forest Management), Haniff Salleh. It was held with the aim that the members will support

regional accreditation activities involving sustainable forest certification including leading a project with funding in ASEAN.

Among the key issues identified during the capacity building exercise were the need of a clearer understanding of forest certification capacity of each AMS and a clear pathway for institutionalisation of a regional certification infrastructure; the need to strengthen institutional framework and capacity of each AMS in relation to forest certification schemes; and to deepen intraregional cooperation to reinforce a regional certification infrastructure.



Touted as the 'Green Carpenter', the owner Harith Ridzuan is committed to produce eco-friendly wood products using sustainable timber and recycled materials.






