A NOTE FROM THE CEO

Dear Reader,

In a media statement on the Economic and Financial Developments in Malaysia in the Second Quarter of 2020 released on 14 August, Bank Negara says the Malaysian economy is forecasted to grow within the range of -3.5% to -5.5% in 2020, before bouncing back within a growth range of 5.5% to 8.0% in 2021. But, the outlook is subject to the uncertainties surrounding commodity and global prices as well as the emerging developments of COVID-19.

Speaking at the General Debate of the 75th Session of the United Nations General Assembly in New York on 26 September, Malaysia's Prime Minister Tan Sri Muhyiddin Mohd Yassin said various structural economic reforms and economic revitalisation programmes have been put in place to address the socio-economic impact of the COVID-19 pandemic. However, he said, balancing between kick-starting the Malaysian economy and implementing the Standard Operating Procedures (SOPs) to curb further waves of infection "has been nothing short of challenging."

Echoing the Prime Minister's statement, weathering the pandemic impact to ensure smooth-flowing implementation process of the Malaysian Timber Certification Scheme (MTCS) is not an easy task for MTCC. Thus, despite the projected growth of the country's economy, we are steadfast in continuing our effort to help our multi-stakeholders remain resilient, buoyant and vigilant in this challenging time. Strictly adhering to the SOPs to contain the virus spread remains at the top of MTCC's agenda when it comes to organising events and activities for our stakeholders. For instance, the introduction of the Malaysian Criteria and Indicators for Sustainable Forest Management (MC&I SFM) was conducted via a webinar in July, while the revised PEFC International Chain of Custody Standard, PEFC ST 2002:2020 Chain of Custody of Forest and Tree Based Products-Requirements, was introduced to the multi-stakeholders through a series of online briefings via Zoom in September.

On other developments, MTCC recently had a meeting with the Menteri Besar of Kelantan, Dato' Ahmad Yakob and members of the State Forestry Committee where the state has pledged its commitment to reobtain forest management certification. A study to evaluate the implementation of forest certification, specifically the MTCS in Malaysia, is underway. The study, Impact of MTCS on Forest Management, Industry and Trade, is being carried out by the Institute of Environment and Development (LESTARI), Universiti Kebangsaan Malaysia (UKM), Malaysian Timber Industry Board (MTIB) and MTCC.

Last but not least, I am pleased to welcome Mr Pubadi Govindasamy from the Ministry of Plantation Industries and Commodities as the new MTCC board member effective 1 September 2020. He replaces Ms Eleine Juliana Malek who ended her tenure to further her studies. We wish Ms Eleine well in her future endeavours.

21ST AGM: BETTER FINANCIAL STATE FOR MTCC IN 2019

The 21st Annual General Meeting (AGM) of MTCC was held at its office premises on 28 July. The main aims of the AGM were to receive and adopt MTCC Annual Report 2019, and to receive and adopt the Audited Financial Reports of MTCC for the financial year ended 31 December 2019 together with the Reports of the Trustees and Auditors.

In presenting the Annual Report, MTCC CEO, Yong Teng Koon highlighted the various achievements of MTCC in 2019. He singled out the successful conduct of the 20th anniversary celebration, the adoption of the revised Vision and Mission, and the MTCC Strategy 2020-2025 as the key highlights for the year. Yong said the Vision encapsulates revised MTCC's determination to see Malaysia as "A nation that appreciates and internalises the full value and contribution of forest towards global sustainability" and the MTCC Strategy 2020-2025 serves as the shorter-term measures toward this endeavour.

MTCC Chairman, Kamaruzaman Mohamad tabled the Audited Financial Reports of MTCC for the financial year ended 31 December 2019 together with the Reports of the Trustees and Auditors. The Chairman reported that the accounts have been properly drawn up in accordance with the Malaysian Financial Reporting Standards, International Financial Reporting Standards and the requirements of the Companies Act 2016 so as to give a true and fair view of the financial position of MTCC as of 31 December 2019. He was pleased to highlight the overall better financial state of the Council last year with an increase of RM6,289,881 or 7.01% in the "Total Equity and Liabilities" as compared to 2018.

As a result of travel restriction imposed by the Covid-19 pandemic, it was a first for the AGM to have members participating both physically and virtually. Also, in attendance were some members of the Board of Trustees, MTCC Company Secretary and a representative from the external auditor firm, Messrs Mazars.

CREATING AWARENESS AMONGST LOCAL COMMUNITIES ON CERTIFICATION VALUES

MTCC participated in a seminar on Communities and the Malaysian Timber Certification Scheme (MTCS) organised by Samling Sdn Bhd on 25 September in Miri, Sarawak. The objective of the seminar was to create awareness on certification process and to provide a platform for an open discussion on how the requirements of certification standard could benefit the local communities.

The seminar was attended by 86 participants from 27 organisations including representatives from indigenous people associations/groups and NGOs such as Save Rivers, Keruan Organisation, Ulu National Assocaition (OUNA), Federation of Orang Ulu Association Sarawak Malaysia (FORUM), Rurum Kelabit Sarawak, Persatuan Kayan Sarawak. Persatuan Kebangsaan Kenyah Sarawak, Persatuan Saban Sarawak, Persatuan Bisaya Sarawak, Persatuan Lun Bawang Sarawak, Penipong Melawan Sarawak (Berawan) and the Gerenai Community Right Action Committee (GCRAC).

Six papers were presented at the one-day seminar. Evelyn Jugi from Forest Department Sarawak spoke about the state's policy on mandatory certification while Siti Mustapha from MTCC explained about the MTCS and its roles and implementation. Khairul Najwan Ahmad Jahari from SIRIM QAS International Sdn Bhd talked about third-party auditing process followed by a paper on High Conservation Value Areas presented by Dr Samantha Liew from WWF. Dr Roland Kueh from Forestry Science Department, Universiti Putra Malaysia (Bintulu campus) described the conduct of social impact assessment and Peter Kallang from Save Rivers highlighted the indigenous peoples' concerns on the rights to manage their land and the interpretation of "free, prior and informed consent". The presentations were followed by a Q&A session moderated by Dr Jason Hon from WWF.

The seminar provided a good platform for participants to gain further understanding on certification and the roles and functions of the various agencies involved in implementing sustainable forest management in Sarawak.

WORKSHOP ON FOREST CERTIFICATION PROCESS AND IMPLEMENTATION IN PENINSULAR MALAYSIA

A study titled The Impact of MTCS on Forest Management, Industry and Trade is currently being conducted to evaluate the impact of implementation of forest certification in Malaysia. The study is a joint effort by the Institute of Environment and Development (LESTARI), Universiti Kebangsaan Malaysia Malaysian Timber Industry Board (MTIB) and MTCC to evaluate the effectiveness and impact of the MTCS on forest management practices, timber industry and trade among government agencies, certified forest and industry sectors, logging companies, primary and secondary timber processing companies and timber traders.

A two-day workshop was held at the Forestry Department Peninsular Malaysia's Forest Training Institute in Kepong to obtain feedback from the participants (forest managers) on the process and implementation of forest certification under the MTCS, identify factors and constraints faced, as well as options/proposals to enhance the implementation of forest certification in Malaysia. The workshop was attended by 45 participants from the Forestry Department Peninsular Malaysia Headquarters, Forest Training Institute and the various State Forest Departments in Peninsular Malaysia.

PUBLIC CONSULTATION ON RE-ENDORSEMENT OF THE MALAYSIAN TIMBER CERTIFICATION SCHEME BY PEFC

Operating a scheme that is endorsed by the Programme for the Endorsement of Forest Certification (PEFC), MTCC is required to revise its certification standards and other relevant technical documents once every five years. The revision ensures that latest development in PEFC requirements, new scientific information, practical experience gained in the field, and expectations as well as aspirations of society towards sustainable forest management are considered by the national schemes and implemented as part of PEFC's commitment to continuous improvement.

Following the approval by the 83rd Meeting of the Board of Trustees, MTCC has submitted its revised standards and other relevant MTCS documentation to PEFC for re-endorsement on 1 July 2020. PEFC is currently conducting a 60-day global public consultation on the revised MTCS from 18 August to 17 October 2020 to seek feedback from stakeholders on any aspect of the scheme. A webinar was also organised by PEFC on 8 September to allow MTCC to introduce the revised MTCS standards and technical documents to the interested stakeholders.

WEBINAR ON MC&I SFM

About 140 participants representing government agencies, social and environmental interest groups, industry, certification bodies, academic institutions as well as students from the Peninsula, Sabah and Sarawak attended a three-hour webinar to introduce the Malaysian Criteria and Indicators for Sustainable Forest Management (MC&I SFM) conducted by MTCC on 21 July.

In his welcoming remarks, MTCC CEO, Yong Teng Koon commented that the MC&I SFM is the outcome of an extensive standard review process which took place from 2015 to 2019. This 2-in-1 standard replaces the MC&I(Natural Forest) and MC&I Forest Plantation v.2 standards. As a scheme endorsed by the Programme for the Endorsement of Forest Certification (PEFC), the standard also incorporates relevant PEFC benchmarks for sustainable forest management.

Yong also provided an update on the implementation of the MTCS and highlighted the current progress of MTCS.

The presentation on the requirements of MC&I SFM was made by Senior Manager (Forest Management), Siti Syaliza Mustapha who highlighted that the revised standard contains nine principles, 49 criteria, and 99 indicators for natural forest (NF) and 105 indicators for forest plantation (FP).

She drew the attention of the participants to the key changes to the standard and highlighted the inclusion of a number of new requirements related to the conversion of severely degraded forest to forest plantation, afforestation of ecological important non-forest ecosystem, interpretation for internal audit and management review, the need for continual improvement, and interpretation on requirements for communicating claims from certified area.

The participants were further informed that the MC&I SFM was launched by MTCC on 1 April 2020 and will come into force on 1 January 2021.



MTCC INTRODUCES REVISED PEFC INTERNATIONAL COC STANDARD

MTCC organised a series of briefing sessions to introduce the revised PEFC International Chain of Custody (CoC) Standard, PEFC ST 2002:2020 Chain of Custody of Forest and Tree Based Products-Requirements.

The PEFC ST 2002:2020, which replaces the PEFC ST 2002:2013 Chain of Custody of Forest Based Product-Requirements Second Edition dated 7 December 2015, will come into effect from 14 Feb 2022.

MTCC kick started the series with an introductory three-hour webinar on 10 September where participants were provided with an overview related to the revision process, and the key changes made in the revised standard. It was followed by five one-hourly sessions held from 21-25 September, with each session focusing on one chapter of the standard.

The online briefing sessions were conducted by Manager (Product), Sabrina Mawasi, Senior Executive (Product), Akmal Saarani and Executive (Product), Adibah Mohamad Aris via Zoom.

The sessions were well attended by participants representing the various timber-related industries in Malaysia with an average attendance of 157 participants per session.

Winning Photos

I was resting under a tree and from my spot, the tree was like a giant bonsai overlooking the mountains. The view was simply magnificent so I quickly took out my camera and snapped it," he said.

"What makes Chua's photo special is its striking and unusual perspective. The three judges didn't see such a viewpoint from the other entries. The tree overhead matches nicely with the slanting and shape of the mountains in the distance. MTCC Chairman, Kamaruzaman said the contest was in line with MTCC's new Vision and Mission which emphasise on the importance of sustainable forest management to be internalised and appreciated at the national level if global sustainability is to be achieved.

"The contest is part of MTCC's continued initiatives to reach out to the public through increased communication, education and public awareness efforts. It also jives well with the fifth thrust of the MTCC Strategy 2020-2025, a short-term plan formulated from the new Vision and Mission which focuses on ensuring that the Malaysian Timber Certification Scheme (MTCS) continues to be relevant in sustainable forest management efforts locally and globally," he said.



JUST HALF OF MAJOR TIMBER AND PULP SUPPLIERS COMMITTED TO ZERO DEFORESTATION

The latest report published by the Sustainability Policy Transparency Toolkit or SPOTT, a corporate transparency initiative launched in 2014 by the Zoological Society of London, highlights the lack of forest protection efforts among the world's 100 most significant timber and pulp companies, with only half being committed to zero deforestation in their supply chains.

The relationship between these companies and their suppliers is one of the weakest areas in this year's report, with a mere 15% having the policies to support contracted smallholders and only 20% would discuss legal requirements and company policy compliance with their suppliers. These results are deemed as unsettling, given the importance of smallholders in tropical countries in reducing deforestation and forest degradation by balancing sustainable forest management and enhancing livelihoods with forest resources.

THE BURNING ISSUE: FIGHTING FOREST FIRES WITH TECHNOLOGY

A number of technological innovations have emerged over the last few years to help prevent and respond to forest fires more effectively. The advent of Internet of Things (IoT) devices and wireless sensors allows early-stage detection and warning, while drones, together with satellite surveillance, enable faster detection and response by the emergency response team. Machine-learning and Artificial Intelligence (AI) are being applied to large datasets to identify environmental threats such as deforestation which increase the risk of major fires. Despite these technological wonders in reducing forest fire incidences, they must be coupled with a long-term commitment - from both the public and private sectors - to sustainable land management and good governance of natural resources.
