Inclusion of the MTCC logo on certificates. All CBs are required to revise their certificate designs to comply with these new requirements.

Revised MTCS Technical Document MTCS ST 3002:2024

We are pleased to announce that the MTCC Board of Trustees has approved the revision to the current MTCS Technical Document MTCS ST 3002:2021 – Procedure for PEFC Notification of Certification Bodies Operating Forest Management System or Chain of Custody Certification. This document outlines the procedure for PEFC notification of Certification Bodies (CBs) operating Forest Management Systems or Chain of Custody certification under the MTCS in Malaysia.

The revised document MTCS ST 3002:2024 stipulated the inclusion of the MTCC logo and other related information on the certificates issued by PEFC-notified CBs under the MTCS. The CBs will be granted a six-month transition date, with effect from 25 June 2024, to allow for a smooth transition and are expected to be in full compliance by 25 December 2024.

The main changes are as follows:

MTCS ST 3002:2024

5.3 The certificate shall include at least the following information:

- a) The certification scheme which the certificate is issued, i.e. the Malaysian Timber Certification Scheme (MTCS);
- b) identification of the certification body;
- c) name of the certificate (i.e. Certificate for Forest Management or Certificate for Chain of Custody);
- d) information of client organisation;
 - for forest management certificate: name of certificate holder,
 name and area (in hectares) of Forest Management Unit/ Forest
 Management Plantation Unit.
 - for Chain of Custody certificate: name of certificate holder, location of certified site and scope of certification, CoC method.
- e) type of certificate (individual, multi-site or producer group);
- f) reference to the standard used (i.e. MC&I SFM or PEFC ST 2002 Chain of Custody of Forest and Tree Based Products Requirements); g) the date of granting, extending or renewing certification and the expiry date or recertification due. The certification shall be granted for a maximum of five years;
- h) MTCC logo with certification body's MTCC licence number;
- i) PEFC logo with the certification body's PEFC licence number;
- j) accreditation mark of the accreditation body (including accreditation number where applicable); and
- k) The number of the certificate

EUDR-PEFC Sustainable Forest Management ST1003 Stakeholder Consultation





MTCC hosted a stakeholder consultation session on 2 July 2024, focusing on aligning the European Union Deforestation Regulation (EUDR) with the Programme for the Endorsement of Forest Certification (PEFC) Sustainable Forest Management (SFM) Standard ST 1003. The event featured opening remarks by MTCC Chief Executive Officer (CEO), Dr. Farrah Shameen Mohamad Ashray, setting the stage for a comprehensive briefing by Director (Forest Management) Dr Agkillah Maniam, who detailed the proposed modifications and their implications for the Malaysian context. This session was attended by representatives from ministries, government agencies, state forestry departments and industry players.

MTCC received a courtesy visit from the Myanmar Forest Certification Committee (MFCC) delegation, led by MFCC National Secretary, Mr Barber Cho and Technical Officer (System Documents), Ms Moh Moh Maung Zin on 14 June 2024. The delegation was welcomed by MTCC Chief Executive Officer, Dr Farrah Shameen Mohamad Ashray, Deputy Chief Executive Officer, Sabrina Mawasi, Director of Forest Management Dr Agkillah Maniam, and Acting Director of Communication and Marketing Muhammad Hasif Azizan.

During the visit, Dr. Farrah provided a briefing on the establishment of MTCC and the operations of the MTCS. The briefing also covered the issues and challenges in operating the MTCS and the strategies to address them. MFCC shared their scope in implementing Myanmar Timber Legality Assurance System (MTLAS) and their certification as well as the various new forestry and logging policies of Myanmar.

Both agencies spoke about the challenges managing the certification issues of deforestation and way forward for strengthening the Asian voice in PEFC.
