Objectives :	<p>The objectives of the standard review of MTCS ST 1002 and MTCS ST 1003 are:</p> <ul style="list-style-type: none"> • To ensure the standards fully comply with the latest PEFC International Benchmarks (PEFC ST 1002 & PEFC ST 1003); • To ensure the standard remains relevant and updated with regards to national and international laws and policies as well as trends in sustainable forest management; and • To improve the clarity and verifiability of all criteria and indicators.
Scope :	<ul style="list-style-type: none"> • This standard review covers all requirements of MTCS ST 1002 and MTCS ST 1003. • Alignment of MTCS forest classification with national and international forest classifications. • Alignment of MTCS with other Malaysian standards related to sustainability, forestry, and plantations. • Review of the standards will consider, among other matters, as follows: <ul style="list-style-type: none"> ○ Alignment with PEFC Benchmarks ○ National and international legal requirements. ○ Malaysia's sustainability policies and international commitments. ○ Environmental sustainability and ecosystem management. ○ Aspirations of forest related communities, dependents, industries and public interest. ○ Economic viability and market access.

Justification for Review :	<ul style="list-style-type: none"> • To ensure the standards stay relevant and updated to the evolving needs of its stakeholders. • Review of the standards every five year is required by MTCS ST 1001 – Standard Setting Procedures for Forest Management Certification Standards (Click for document) and the PEFC Benchmarks. • Required to ensure full legal compliance by incorporating new Malaysian laws and to strategically align the standard with emerging national ESG (Environmental, Social, and Governance) priorities. • Allowing MTCC to address evolving global trade demands, such as the EU Deforestation Regulation (EUDR), thereby safeguarding market access and the long-term competitiveness of Malaysian certified timber.
Intended outcome :	<p>The revised MTCS ST 1002 and MTCS ST 1003 will:</p> <ul style="list-style-type: none"> • Successfully complete the PEFC re-endorsement process, confirming full compliance with the latest PEFC International Benchmarks and securing uninterrupted international market recognition. • Demonstrably aligned with all current Malaysian laws, regulations and policies, and global demands (e.g., EUDR), making the MTCS a robust mechanism for certifying sustainable forest management and addressing deforestation risk. • Includes in a balanced manner the evolving needs of its stakeholders. • Consider trends in sustainable forest management such as ESG, carbon project, etc. • Enhance clarity and practicality for implementation.
